No. 59 abducted [him] or violate or abuse the person abducted [him] 1 2 sexually; 3 (E) [(5)] terrorize the person abducted [him] or 4 a third person; [or] 5 (F) [(6)] interfere with the performance of any governmental or political function; or 6 (G) hold the person abducted in a condition of 7 8 involuntary servitude; or 9 (2) the person intentionally or knowingly abducts 10 another person who is: (A) younger than 18 years of age; or 11 12 (B) incompetent. SECTION 3. Chapter 20, Penal Code, is amended by adding 13 Section 20.06 to read as follows: 14 Sec. 20.06. TRAFFICKING OF PERSONS. (a) In this section: 15 16 (1) "Forced labor or services" means labor or services that are performed or provided by another person and obtained 17 through an actor's: 18 19 (A) threatening to cause bodily injury to 20 another; (B) restraining another in a manner described by 21 Section 20.01(1); or 22 23 (C) withholding from another the person's: 24 (i) government records; (ii) identifying information; or 25 26 (iii) personal property. (2) "Traffic" means to transport another person or to 27

3	(b(1) A person commits an offense if the person knowingly

only to an offense committed on or after the effective date of this Act. For purposes of this section, an offense was committed before the effective date of this Act if any element of the offense was committed before that date.

5 (b) An offense committed before the effective date of this 6 Act is covered by the law in effect when the offense was committed, 7 and the former law is continued in effect for that purpose.
