registered in the precinct in which the voter is offering to vote,
but whose name is not on the precinct list of registered voters,
shall be accepted for voting <u>if the voter's identity can be verified</u>
from the proof presented.

8 SECTION 5. Section 63.007(a), Election Code, is amended to 9 read as follows:

10 (a) A voter who, when offering to vote, presents a voter 11 registration certificate indicating that the voter is currently 12 registered in a different precinct from the one in which the voter 13 is offering to vote, and whose name is not on the precinct list of 14 registered voters, shall be accepted for voting if <u>the voter's</u> 15 <u>identity can be verified from the proof presented and</u> the voter 16 executes an affidavit stating that the voter:

(1) is a resident of the precinct in which the voter is offering to vote or is otherwise entitled by law to vote in that precinct;

(2) was a resident of the precinct in which the voter
is offering to vote at the time that information on the voter's
residence address was last provided to the voter registrar;

(3) did not deliberately provide false information to
secure registration in a precinct in which the voter does not
reside; and

26 (4) is voting only once in the election.
27 SECTION 6. Section 63.008(a), Election Code, is amended to

1 read as follows:

A voter who does not present a voter registration 2 (a) certificate when offering to vote, but whose name is on the list of 3 registered voters for the precinct in which the voter is offering to 4 vote, shall be accepted for voting if the voter executes an 5 affidavit stating that the voter does not have the voter's voter 6 7 registration certificate in the voter's possession at the polling 8 place at the time of offering to vote and the voter's identity can 9 be verified from the proof presented [voter presents proof of identification in a form described by Section 63.0101]. 10

11 SECTION 7. Sections 63.011(a) and (b), Election Code, are 12 amended to read as follows:

(a) A person to whom Section <u>63.001(g)</u>, 63.008(b), or
63.009(a) applies may cast a provisional ballot if the person
executes an affidavit stating that the person:
