No. 1129 An offense under Subsection (e) is a Class C misdemeanor 1 (d) 2 unless it is committed in a habitation or unless the actor carries a 3 deadly weapon on or about the actor's person during the commission 4 of the offense, in which event it is a Class A misdemeanor. An 5 offense under Subsection (k) is a Class C misdemeanor unless it is 6 committed in a building or habitation or unless the actor carries a deadly weapon on or about the actor's person during the commission 7 of the offense, in which event it is a Class A misdemeanor. 8 An offense under Subsection (a) is a Class B misdemeanor, except that 9 the offense is a Class A misdemeanor if: 10 (1) the offense is committed: 11 in a habitation or a shelter center; 12 (A) on a Superfund site; or 13 (B) 14 (C) on or in a critical infrastructure facility; 15 or (2) the actor carries a deadly weapon on or about his 16 17 person during the commission of the offense. 3 (b) An offense committed before the effective date of this 4 Act is covered by the law in effect when the offense was committed, 5 and the former law is continued in effect for that purpose.

6 SECTION 4. This Act takes effect immediately if it receives 7 a vote of two-thirds of all the members elected to each house, as 8 provided by Section 39, Article III, Texas Constitution. If this 9 Act does not receive the vote necessary for immediate effect, this 10 Act takes effect September 1, 2007.
