- BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS: 6
- SECTION 1. COMPOSITION OF COMMITTEE. 7 (a) The Interim
- Special Committee on Electric Energy Generation Capacity and 8
- Environmental Impact is composed of: 9
- (1) the chair of the House Environmental Regulation 10
- 11 Committee;
- 12 (2) the chair of the House Energy Resources Committee;
- 13 the chair of the House Committee on Regulated (3)
