

AN ACT

relating to the boundaries and board of directors of Harris County Improvement District No. 6.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

SECTION 1. Section 3843.051(a), Special District Local Laws Code, is amended to read as follows:

(a) The district is governed by a board of 13 [~~11~~] directors who serve staggered terms of four years with six [~~five~~] or seven [~~six~~] directors' terms expiring June 1 of each odd-numbered year.

SECTION 2. Section 3843.053, Special District Local Laws Code, is amended to read as follows:

4 (b) The [~~Of the initial directors, the~~] terms of directors
5 appointed for positions 1 through 6 expire June 1, 2011 [~~2009~~], and
6 the terms of directors appointed for positions 7 through 13 [~~11~~]
7 expire June 1, 2009 [~~2007~~].

8 (b-1) The term of each membership position on the board as
9 the term exists immediately preceding the effective date of the Act
10 adding this subsection expires on that effective date. On that
11 date, a new board is appointed as provided by Subsection (a) to
12 serve terms as provided by Subsection (b).

13 (c) Section 3843.051 does not apply to this section.

14 (d) This section expires September 1, 2011 [~~2009~~].

15 SECTION 3. Section 2, Chapter 769, Acts of the 79th
16 Legislature, Regular Session, 2005, is amended to read as follows:

17 Sec. 2. BOUNDARIES. The [~~As of the effective date of this~~
18 ~~Act, the~~] Harris County Improvement District No. 6 includes all
19 territory contained in the following described area:

20 Beginning at the intersection of the center right of way line
21 of West Dallas and the center right of way line of Montrose
22 Boulevard;

23 Thence easterly along the center right of way line of West Dallas to
24 its intersection with the center right of way line of Taft Street;

25 Thence southerly along the center right of way line of Taft to its
26 intersection with the center right of way line of Welch;

27 Thence easterly along the center right of way line of Taft crossing

1 the right of way of Genesee following the center right of way line
2 of Dennis to its intersection with the center right of way line of
3 Boston;
4 Thence southerly along the center right of way line of Boston to its
5 intersection with the center right of way line of Genesee;
6 Thence southerly along the center right of way line of Genesee to
7 its intersection with the center right of way line of Tuam;
8 Thence easterly along the center right of way line of Tuam to its
9 intersection of the center right of way line of Bagby;
10 Thence southwesterly along the center right of way line of Bagby
11 Street to its intersection with the center right of way line of Spur
12 527;
13 Thence southerly along the center right of way line of Spur 527 to
14 its intersection with the center right of way line of Elgin;
15 Thence southeasterly along the center right of way line of Elgin to
16 its intersection with the center right of way line of Brazos which
17 is also the center right of way line of Spur 527;
18 Thence southerly along the center right of way line of Spur 527 to
19 its intersection with the center right of way line of Milam;
20 Thence southwesterly along the center right of way line of Milam
21 Street to its intersection with the center right of way line of Spur
22 527;
23 Thence southerly following southwesterly along the center right of
24 way line of Spur 527 to its intersection with the center right of
25 way line of US 59 South;
26 Thence easterly along the center right of way of US 59 South to its
27 intersection with the center right of way line of Main;

1 Thence southwesterly along the center right of way line of Main to
2 the north property line of Block 1, South End Villa according to the
3 map thereof recorded in Volume 1, Page 104 of the Harris County Map
4 Records;

5 Thence westerly along the north property line of said Block 1, South
6 End Villa and the south property line of the C.C. Fitze Homestead
7 Addition according to the plat thereof recorded in Volume 259, Page
8 163 of the Harris County Deed Records, crossing the north dead end
9 of Travis to the center right of way line thereof;

10 Thence southwesterly along the center right of way line of Travis to
11 the center right of way line of Portland;

12 Thence easterly along the center right of way line of Portland to
13 the the center right of way line of Main;

14 Thence southwesterly along the center right of way line of Main to
15 its intersection with the center right of way line of Bissonnet;

16 Thence westerly along the center right of way line of Bissonnet to
17 its intersection with the center right of way line of Graustark;

18 Thence northerly along the center right of way line of Graustark to
19 its intersection with the center right of way line of US 59 South;

20 Thence westerly along the center right of way line of US 59 South to
21 its intersection with the east right of way line of South Shepherd
22 Drive;

23 Thence northerly along the east right of way line of South Shepherd
24 Drive following along the northeast right of way line of Shepherd
25 Drive to its intersection with the center right of way line West
26 Dallas Avenue;

27 Thence easterly along the center right of way line of West Dallas to

1 the PLACE OF BEGINNING.

2 ~~[UNLESS otherwise specified, the boundaries of this district will~~
3 ~~travel along the centerline of each street included, and each~~
4 ~~intersection will be the intersection of the centerlines of the~~

20 ~~line of U.S. Highway 59.~~

22 ~~south boundary line of U.S. Highway 59 proceeding in a~~
23 ~~northeasterly direction along Spur 527, then following Spur 527 in~~
24 ~~a northeasterly direction to its intersection with the easterly~~
25 ~~line of Milam Street.~~

26 ~~Then in a northeasterly direction along Milam Street to its~~
27 ~~intersection with the easterly line of Spur 527.~~

1 ~~Then in a northerly direction along the easterly line of Spur 527 to~~
2 ~~Brazos Street.~~

3 ~~Then in a northeasterly direction along Brazos Street to its~~
4 ~~intersection with Tuam Avenue.~~

5 ~~Then in a northwesterly direction along Tuam Avenue to Bagby~~
6 ~~Street.~~

7 ~~Then in a northeasterly direction along Bagby Street to McGowen~~
8 ~~Avenue.~~

9 ~~Then in a northwesterly direction along the McGowen Avenue to the~~
10 ~~southerly projection of Bailey Street.~~

11 ~~Then following the southerly projection of Bailey Street in a~~
12 ~~northerly direction to Bailey Street.~~

13 ~~Then in a northerly direction along Bailey Street to the southeast~~
14 ~~corner of Lot 10 Block 78 of the W.R. Baker Subdivision, Unrecorded.~~

15 ~~Then in a westerly direction along the south line of said W.R. Baker~~
16 ~~Unrecorded Subdivision, crossing Gillette Street and continuing to~~
17 ~~Genesee Street.~~

18 ~~Then westerly along Welch Street to its intersection with Taft~~
19 ~~Street.~~

20 ~~Then in a northerly direction along Taft Street to its intersection~~
21 ~~with West Dallas Street.~~

22 ~~Then in a westerly direction along West Dallas Street to its~~
23 ~~intersection with Montrose Boulevard at the point of BEGINNING.]~~

24 SECTION 4. The legislature finds that:

25 (1) proper and legal notice of the intention to
26 introduce this Act, setting forth the general substance of this
27 Act, has been published as provided by law, and the notice and a

1 copy of this Act have been furnished to all persons, agencies,
2 officials, or entities to which they are required to be furnished by
3 the constitution and laws of this state, including the governor,
4 who has submitted the notice and Act to the Texas Commission on
5 Environmental Quality;

6 (2) the Texas Commission on Environmental Quality has
7 filed its recommendations relating to this Act with the governor,
8 lieutenant governor, and speaker of the house of representatives
9 within the required time;

10 (3) the general law relating to consent by political
11 subdivisions to the creation of districts with conservation,
12 reclamation, and road powers and the inclusion of land in those
13 districts has been complied with; and

14 (4) all requirements of the constitution and laws of
15 this state and the rules and procedures of the legislature with
16 respect to the notice, introduction, and passage of this Act have
17 been fulfilled and accomplished.

18 SECTION 5. This Act takes effect immediately if it receives
19 a vote of two-thirds of all the members elected to each house, as
20 provided by Section 39, Article III, Texas Constitution. If this
21 Act does not receive the vote necessary for immediate effect, this
22 Act takes effect September 1, 2007.
