A BILL TO BE ENTITLED

1	AN ACT

- 2 relating to territory included in, and the validation of acts of,
- 3 the Greater Southeast Management District.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. The Greater Southeast Management District is
- 6 composed of the territory described by Section 1, Chapter 1476,
- 7 Acts of the 77th Legislature, Regular Session, 2001, enacting
- 8 former Section 376.454, Local Government Code, and the territory
- 9 contained in the following described area:
- 10 BEGINNING at a point being the intersection of the centerline
- of the right-of-way of State Highway 288 and Corder;
- 12 THENCE in a southerly direction along the centerline of State
- 13 Highway 288 to the intersection of State Highway 288 and South Loop
- 14 East;
- 15 THENCE in an easterly direction along the centerline of South
- 16 Loop East to the intersection of the West R.O.W. line of Martin
- 17 Luther King Street;
- 18 THENCE along the rear property line of the lots fronting the
- 19 West R.O.W. line of Martin Luther King Street to the north line of
- 20 Browncroft Street;
- 21 THENCE west along the north line of Browncroft St. passing
- 22 Lisa Lane to the south continuing in a generally west direction to
- 23 the west line of Milart Street;
- 24 THENCE south along the west line of Milart Street to the

- 1 southeast corner of tract 23 of the WCRR Co. Survey A 936;
- 2 THENCE west along the southerly property line of Tract 23 and
- 3 14B of the WCRR Co. Survey A 936 to the east line of Schroeder
- 4 Street;
- 5 THENCE in a northeasterly direction along the easterly line
- of Schroeder Road to its intersection with the southerly line on
- 7 Griggs Road;
- 8 THENCE in a northeasterly direction along the southerly line
- 9 of Griggs Road to the intersection of the rear of the rear property
- 10 line of the lot facing Grace Lane;
- 11 THENCE in a southwesterly direction along the rear property
- 12 line of the lots facing Grace Lane to the intersection of the rear
- 13 property line projection of all lots fronting, more or less the
- 14 north line of Kingsbury Lane;
- 15 THENCE westerly along the rear property line projection of
- 16 all lots fronting the north line of Kingsbury Lane to the east
- 17 right-of-way line of Calhoun Road;
- 18 THENCE northeasterly along the easterly line of Calhoun Road
- 19 to the rear property line projection of the lots fronting on Griggs
- 20 Road;
- 21 THENCE west along the rear property line of all the lots
- 22 fronting on Griggs Road to the east line of Cullen Road;
- THENCE in a southerly direction along the east line of Cullen
- 24 Road to the south line projection of Dixie Street;
- 25 THENCE in a westerly direction along the south line of Dixie
- 26 Street, crossing St. Augustine Street, to the rear line of the lot
- 27 facing St. Augustine St.;

- 1 THENCE north to the rear lot line of the lots that front on
- 2 Old Spanish Trail;
- 3 THENCE west along the rear lot line of the lots that front on
- 4 Old Spanish Trail to the rear property line of the lot that fronts
- 5 on Scottcrest Street;
- 6 THENCE north to the south right-of-way line of Old Spanish
- 7 Trail;
- 8 THENCE west to the intersection of the east line of
- 9 Scottcrest Street;
- 10 THENCE in a southwesterly direction to the rear property line
- of all lots that front Zephyr Street to the west right-of-way line
- 12 of La Sallette Drive;
- 13 THENCE northwesterly along the west right-of-way line of
- 14 LaSallette Drive to the intersection of the south right-of-way line
- of Old Spanish Trail;
- THENCE southwesterly along the south right-of-way line of Old
- 17 Spanish Trail to rear property line of the corner lot fronting on
- 18 Tierwester Street;
- 19 THENCE south along the rear property line of the corner lot
- 20 fronting Tierwester Street to the southeast corner of this lot;
- 21 THENCE west along the south line of the corner lot fronting on
- 22 Tierwester Street to the east right-of-way line of Tierwester
- 23 Street;
- 24 THENCE southerly along the east right-of-way line of
- 25 Tierwester Street to the south property line of Zephyr Street;
- THENCE west crossing Tierswater Street, where the street name
- 27 changes from Zephyr Street to Southland Avenue and along the south

- 1 line of Southland Avenue to the intersection of the south
- 2 right-of-way line of Old Spanish Trail;
- 3 THENCE in a southwesterly direction along the south line of
- 4 Old Spanish Trail to the east line of Allegheny Street;
- 5 THENCE south along the east right-of-way line of Allegheny
- 6 Street the southeast corner of the first corner lot;
- 7 THENCE east along the south line of the corner lot to the rear
- 8 property line;
- 9 THENCE south along the rear property line for one lot long to
- 10 the southeast corner of this lot fronting on the east line of
- 11 Allegheny Street;
- 12 THENCE west to the east property line of Allegheny Street;
- 13 THENCE in a southwesterly direction along the east
- 14 right-of-way line of Allegheny Street to the intersection of the
- 15 north right-of-way line of Yellowstone Street;
- 16 THENCE in a southeasterly direction along the north
- 17 right-of-way line of Yellowstone Street to the east right-of-way
- 18 line of Peerless Street;
- 19 THENCE in a southerly direction along the east right-of-way
- 20 line of Peerless Street to the intersection of the south
- 21 right-of-way line of Corder Street;
- THENCE in a northwesterly direction along the southerly line
- 23 of Corder Street to the intersection of the centerline of State
- 24 Highway 288, the Point of Beginning, SAVE AND EXCEPT all tracts or
- 25 parcels of land, right of way, facilities and improvements owned by
- 26 a utility.
- 27 SECTION 2. (a) The legislature validates and confirms all

- 1 governmental acts and proceedings of the Greater Southeast
- 2 Management District of Harris County, including acts of the
- 3 district's board of directors, that occurred before the effective
- 4 date of this Act.
- 5 (b) This section does not apply to any matter that on the
- 6 effective date of this Act:
- 7 (1) is involved in litigation if the litigation
- 8 ultimately results in the matter being held invalid by a final court
- 9 judgment; or
- 10 (2) has been held invalid by a final court judgment.
- 11 SECTION 3. The legislature finds that:
- 12 (1) proper and legal notice of the intention to
- 13 introduce this Act, setting forth the general substance of this
- 14 Act, has been published as provided by law, and the notice and a
- 15 copy of this Act have been furnished to all persons, agencies,
- officials, or entities to which they are required to be furnished by
- 17 the constitution and laws of this state, including the governor,
- 18 who has submitted the notice and Act to the Texas Commission on
- 19 Environmental Quality;
- 20 (2) the Texas Commission on Environmental Quality has
- 21 filed its recommendations relating to this Act with the governor,
- 22 lieutenant governor, and speaker of the house of representatives
- 23 within the required time;
- 24 (3) the general law relating to consent by political
- 25 subdivisions to the creation of districts with conservation,
- 26 reclamation, and road powers and the inclusion of land in those
- 27 districts has been complied with; and

1 (4) all requirements of the constitution and laws of
2 this state and the rules and procedures of the legislature with
3 respect to the notice, introduction, and passage of this Act have
4 been fulfilled and accomplished.
5 SECTION 4. This Act takes effect immediately if it receives
6 a vote of two-thirds of all the members elected to each house, as
7 provided by Section 39, Article III, Texas Constitution. If this

Act does not receive the vote necessary for immediate effect, this

Act takes effect September 1, 2007.
