- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. DEFINITIONS. In this Act:
- 6 (1) "Authority" means the Angelina and Neches River
- 7 Authority.
- 8 (2) "Board" means the Texas Water Development Board.
- 9 (3) "Project" means the proposed Lake Columbia
- 10 reservoir project authorized by Permit to Appropriate State Water
- 11 Number 4228 (Application No. 4537).
- 12 SECTION 2. LEGISLATIVE FINDINGS. The legislature finds
- 13 that:
- 14 (1) the project is a rural water project for political
- 15 subdivisions;
- 16 (2) the construction and development of the project
- 17 are in the public interest;
- 18 (3) the board has committed to the authority to
- 19 acquire, through the use of money in the Texas Water Development
- 20 Fund II state participation account, an interest in the project for
- 21 an amount not to exceed 50 percent of the total project costs in
- 22 order to support the optimum regional development of the project's
- 23 site; and
- 24 (4) the board has determined that it is reasonable to

- 1 expect that the state will recover its investment in the facility.
- 2 SECTION 3. BOARD DISCRETION IN MAKING FINDINGS. (a) In
- 3 making any statutory finding under Section 16.135(1), Water Code,
- 4 necessary to complete financing of the project, the board may take
- 5 into account any revenue reasonably expected to be received from:
- 6 (1) a political subdivision not currently under
- 7 contract with the authority to participate in paying the costs of
- 8 the site acquisition stage of the project; or
- 9 (2) a political subdivision not currently under
- 10 contract to purchase a portion of the water to be supplied by the
- 11 project.
- 12 (b) The board is not required to identify a political
- 13 subdivision from which revenue is reasonably expected to be
- 14 received as provided by Subsection (a) of this section at the time
- 15 the board makes a finding described by that subsection.
- 16 SECTION 4. EFFECTIVE DATE. This Act takes effect
- 17 immediately if it receives a vote of two-thirds of all the members
- 18 elected to each house, as provided by Section 39, Article III, Texas
- 19 Constitution. If this Act does not receive the vote necessary for
- 20 immediate effect, this Act takes effect September 1, 2009.
