adopt rules in accordance with Section 54.053, Education Code, as amended by this Act, prescribing the documentation required for a public institution of higher education to verify that a person applying for resident status is authorized by law to be present in the United States. The coordinating board may adopt the initial rules in the manner provided by law for emergency rules.

7 SECTION 4. The changes in law made by this Act apply 8 beginning with resident status at public institutions of higher 9 education for the 2009 fall semester. Resident status for a 10 semester or session before the 2009 fall semester is governed by the 11 applicable law in effect before the effective date of this Act, and 12 that law is continued in effect for that purpose.

13 SECTION 5. This Act takes effect immediately if it receives 14 a vote of two-thirds of all the members elected to each house, as 15 provided by Section 39, Article III, Texas Constitution. If this 16 Act does not receive the vote necessary for immediate effect, this 17 Act takes effect September 1, 2009.
