A BILL TO BE ENTITLED

1 AN ACT
2 relating to the composition of the districts for the election of
3 members of the State Board of Education.

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

5 ARTICLE I

6 SECTION 1. (a) The members of the State Board of Education
7 are elected from the districts described by Article II of this Act.

8 (b) One member is elected from each district established by
9 this Act.

10 (c) The districts established by this Act are identified as
11 PLANE111 on the redistricting computer system operated by the Texas
12 Legislative Council.

13 (d) For purposes of Section 7.104, Education Code, this Act
14 constitutes a decennial reapportionment.

15 ARTICLE II

19 ARTICLE III

20 SECTION 1. In this Act, "tract," "block group," and "block"
21 mean the geographic areas identified by those terms on the 2010
22 Census TIGER/Line Shapefiles, prepared by the federal Bureau of the
23 Census for the Twenty-third Decennial Census of the United States,
24 enumerated as of April 1, 2010.

25 SECTION 2. It is the intention of the Texas Legislature
26 that, if any county, tract, block group, block, or other geographic
27 area has erroneously been left out of this Act, a court reviewing

1 this Act should include that area in the appropriate district in
2 accordance with the intent of the legislature, using any available
3 evidence of that intent, including evidence such as that used by the
4 Supreme Court of Texas in Smith v. Patterson, 111 Tex. 535, 242 S.W.
5 749 (1922).

6 SECTION 3. (a) Section 7.101(a), Education Code, is
7 amended to read as follows:

8 (a) The State Board of Education is composed of 15 members
9 elected from districts. [~~Each district from which a board member is
10 elected is composed as provided by former Sections 11.2101(b)-(t),
11 as enacted by Chapter 2, Acts of the 72nd Legislature, 2nd Called
12 Session, 1991.~~]

13 (b) This Act supersedes all previous enactments or orders
14 adopting districts for the State Board of Education. All previous
15 acts of the legislature adopting districts for the State Board of
16 Education are repealed.

17 SECTION 4. The districts established by this Act apply to
18 the election of the members of the State Board of Education
19 beginning with the primary and general elections in 2012 for
20 members of the board in 2013. This Act does not affect the
21 membership or districts of the board before January 1, 2013.

22 SECTION 5. This Act takes effect immediately if it receives
23 a vote of two-thirds of all the members elected to each house, as
24 provided by Section 39, Article III, Texas Constitution. If this
25 Act does not receive the vote necessary for immediate effect, this
26 Act takes effect on the 91st day after the last day of the
27 legislative session.
