1-8 A BILL TO BE ENTITLED
1-9 AN ACT

1-10 relating to the composition of the districts for the election of
1-11 members of the State Board of Education.

1-12 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

1-13 ARTICLE I

1-14 SECTION 1. (a) The members of the State Board of Education
1-15 are elected from the districts described by Article II of this Act.

1-16 (b) One member is elected from each district established by
1-17 this Act.

1-18 (c) The districts established by this Act are identified as
1-19 PLANE120 on the redistricting computer system operated by the Texas
1-20 Legislative Council.

1-21 (d) For purposes of Section 7.104, Education Code, this Act
1-22 constitutes a decennial reapportionment.

1-23 ARTICLE II

30-66 SECTION 5. This Act takes effect immediately if it receives
30-67 a vote of two-thirds of all the members elected to each house, as

30-69 Act does not receive the vote necessary for immediate effect, this
