## A BILL TO BE ENTITLED

- 2 relating to contracts by governmental entities and related
- 3 professional services and to public works performance and payment
- 4 bonds.
- 5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 6 ARTICLE 1. PUBLIC WORKS PERFORMANCE AND PAYMENT BONDS
- 7 SECTION 1.01. Section 2253.021, Government Code, is amended
- 8 by adding Subsection (h) to read as follows:
- 9 (h) A reverse auction procedure may not be used to obtain
- 10 services related to a public work contract for which a bond is
- 11 required under this section. In this subsection, "reverse auction
- 12 procedure" has the meaning assigned by Section 2155.062 or a
- 13 procedure similar to that described by Section 2155.062.
- 14 ARTICLE 2. CONTRACTS BY GOVERNMENTAL ENTITIES
- SECTION 2.01. Section 11.168, Education Code, is amended to
- 16 read as follows:
- 17 Sec. 11.168. USE OF DISTRICT RESOURCES PROHIBITED FOR
- 18 CERTAIN PURPOSES; EXCEPTION. (a) Except as provided by <u>Subsection</u>
- 19 (b) or Section 45.109 (a-1) or [and] (a-2), the board of trustees of
- 20 a school district may not enter into an agreement authorizing the
- 21 use of school district employees, property, or resources for the
- 22 provision of materials or labor for the design, construction, or
- 23 renovation of improvements to real property not owned or leased by
- 24 the district.

- 1 (b) This section does not prohibit the board of trustees of
- 2 a school district from entering into an agreement for the design,
- 3 <u>construction</u>, <u>or renovation of improvements to real property not</u>
- 4 owned or leased by the district if the improvements benefit real
- 5 property owned or leased by the district. Benefits to real property
- 6 owned or leased by the district include the design, construction,
- 7 or renovation of highways, roads, streets, sidewalks, crosswalks,
- 8 utilities, and drainage improvements that serve or benefit the real
- 9 property owned or leased by the district.
- SECTION 2.02. Sections 44.031(a) and (f), Education Code,
- 11 are amended to read as follows:
- 12 (a) Except as provided by this subchapter, all school
- 13 district contracts for the purchase of goods and services, except
- 14 contracts for the purchase of produce or vehicle fuel, valued at
- 15 \$50,000 or more in the aggregate for each 12-month period shall be
- 16 made by the method, of the following methods, that provides the best
- 17 value for the district:
- 18 (1) competitive bidding for services other than
- 19 construction services;
- 20 (2) competitive sealed proposals for services other
- 21 than construction services;
- 22 (3) a request for proposals, for services other than
- 23 construction services;
- 24 (4) an interlocal contract <u>for services other than</u>
- 25 construction services;
- 26 (5) <u>a method provided by Chapter 2267, Government</u>
- 27 Code, for construction services [a design/build contract;

- 1 [(6) a contract to construct, rehabilitate, alter, or
- 2 repair facilities that involves using a construction manager;
- 3 [(7) a job order contract for the minor construction,
- 4 repair, rehabilitation, or alteration of a facility];
- 5 (6)  $[\frac{(8)}{(8)}]$  the reverse auction procedure as defined by
- 6 Section 2155.062(d), Government Code; or
- 7  $\underline{(7)}$  [ $\underline{(9)}$ ] the formation of a political subdivision
- 8 corporation under Section 304.001, Local Government Code.
- 9 (f) This section does not apply to a contract for
- 10 professional services rendered, including services of an
- 11 architect, attorney, engineer, or fiscal agent. A school district
- 12 may, at its option, contract for professional services rendered by
- 13 a financial consultant or a technology consultant in the manner
- 14 provided by Section 2254.003, Government Code, in lieu of the
- 15 methods provided by this section.
- SECTION 2.03. Subchapter B, Chapter 44, Education Code, is
- 17 amended by adding Sections 44.0351 and 44.0352 to read as follows:
- 18 Sec. 44.0351. COMPETITIVE BIDDING. (a) Except to the
- 19 extent prohibited by other law and to the extent consistent with
- 20 this subchapter, a school district may use competitive bidding to
- 21 select a vendor as authorized by Section 44.031(a)(1).
- 22 (b) Except as provided by this subsection, Subchapter B,
- 23 Chapter 271, Local Government Code, does not apply to a competitive
- 24 bidding process under this subchapter. Sections 271.026,
- 25 <u>271.027(a)</u>, and <u>271.0275</u>, <u>Local Government Code</u>, <u>apply to a</u>
- 26 competitive bidding process under this subchapter.
- 27 (c) A school district shall award a competitively bid

- 1 contract at the bid amount to the bidder offering the best value for
- 2 the district. In determining the best value for the district, the
- 3 district is not restricted to considering price alone but may
- 4 consider any other factors stated in the selection criteria. The
- 5 selection criteria may include the factors listed in Section
- 6 44.031(b).
- 7 Sec. 44.0352. COMPETITIVE SEALED PROPOSALS. (a) In
- 8 <u>selecting a vendor through competitive sealed proposals as</u>
- 9 <u>authorized by Section 44.031(a)(2)</u>, a school district shall follow
- 10 the procedures prescribed by this section.
- 11 (b) The district shall prepare a request for competitive
- 12 sealed proposals that includes information that vendors may require
- 13 to respond to the request. The district shall state in the request
- 14 for proposals the selection criteria that will be used in selecting
- 15 <u>the successful offeror.</u>
- 16 (c) The district shall receive, publicly open, and read
- 17 aloud the names of the offerors and, if any are required to be
- 18 stated, all prices stated in each proposal. Not later than the 45th
- 19 day after the date on which the proposals are opened, the district
- 20 shall evaluate and rank each proposal submitted in relation to the
- 21 published selection criteria.
- 22 (d) The district shall select the offeror that offers the
- 23 best value for the district based on the published selection
- 24 criteria and on its ranking evaluation. The district shall first
- 25 attempt to negotiate a contract with the selected offeror. The
- 26 district may discuss with the selected offeror options for a scope
- 27 or time modification and any price change associated with the

- 1 modification. If the district is unable to negotiate a
- 2 satisfactory contract with the selected offeror, the district
- 3 shall, formally and in writing, end negotiations with that offeror
- 4 and proceed to the next offeror in the order of the selection
- 5 ranking until a contract is reached or all proposals are rejected.
- 6 (e) In determining the best value for the district, the
- 7 district is not restricted to considering price alone but may
- 8 consider any other factors stated in the selection criteria.
- 9 SECTION 2.04. Subchapter B, Chapter 44, Education Code, is
- 10 amended by adding Section 44.0411 to read as follows:
- Sec. 44.0411. CHANGE ORDERS. (a) If a change in plans or
- 12 specifications is necessary after the performance of a contract is
- 13 begun or if it is necessary to decrease or increase the quantity of
- 14 work to be performed or of materials, equipment, or supplies to be
- 15 furnished, the district may approve change orders making the
- 16 <u>changes</u>.
- 17 (b) The total contract price may not be increased because of
- 18 the changes unless additional money for increased costs is approved
- 19 for that purpose from available money or is provided for by the
- 20 authorization of the issuance of time warrants.
- 21 <u>(c) The district may grant general authority to an</u>
- 22 administrative official to approve the change orders.
- 23 (d) A contract with an original contract price of \$1 million
- 24 or more may not be increased under this section by more than 25
- 25 percent. If a change order for a contract with an original contract
- 26 price of less than \$1 million increases the contract amount to \$1
- 27 million or more, the total of the subsequent change orders may not

- 1 increase the revised contract amount by more than 25 percent of the
- 2 original contract price.
- 3 SECTION 2.05. Subchapter A, Chapter 46, Education Code, is
- 4 amended by adding Section 46.0111 to read as follows:
- 5 Sec. 46.0111. ACTIONS BROUGHT FOR DEFECTIVE DESIGN,
- 6 CONSTRUCTION, RENOVATION, OR IMPROVEMENT OF INSTRUCTIONAL
- 7 FACILITY. (a) In this section:
- 8 (1) "Net proceeds" means the difference between the
- 9 amount recovered by or on behalf of a school district in an action,
- 10 by settlement or otherwise, and the legal fees and litigation costs
- 11 incurred by the district in prosecuting the action.
- 12 (2) "State's share" means an amount equal to the
- 13 <u>district's net proceeds from the recovery multiplied by a</u>
- 14 percentage determined by dividing the amount of state assistance
- 15 under this subchapter used to pay the principal of and interest on
- 16 bonds issued in connection with the instructional facility that is
- 17 the subject of the action by the total amount of principal and
- 18 interest paid on the bonds as of the date of the judgment or
- 19 settlement.
- 20 (b) A school district that brings an action for recovery of
- 21 damages for the defective design, construction, renovation, or
- 22 improvement of an instructional facility financed by bonds
- 23 for which the district receives state assistance under this
- 24 subchapter shall provide the commissioner with written notice of
- 25 the action.
- 26 (c) The commissioner may join in the action on behalf of the
- 27 state to protect the state's share in the action.

- 1 (d) A school district shall use the net proceeds from an
- 2 action brought by the district for the defective design,
- 3 construction, renovation, or improvement of an instructional
- 4 facility financed by bonds for which the district receives state
- 5 assistance under this subchapter to repair the defective design,
- 6 construction, renovation, or improvement of the instructional
- 7 <u>facility on which the action is brought or to replace the facility.</u>
- 8 Section 46.008 applies to the repair.
- 9 (e) The state's share is state property. The school
- 10 district shall send to the comptroller any portion of the state's
- 11 share not used by the school district to repair the defective
- 12 design, construction, renovation, or improvement of the
- 13 instructional facility on which the action is brought or to replace
- 14 the facility. Section 42.258 applies to the state's share under
- 15 this subsection.
- SECTION 2.06. Section 791.011, Government Code, is amended
- 17 by amending Subsection (h) and adding Subsection (i) to read as
- 18 follows:
- 19 (h) An interlocal contract or any other agreement between a
- 20 governmental entity and a purchasing cooperative may not be used to
- 21 purchase engineering or architectural services.
- (i) An interlocal contract may not be used to purchase
- 23 construction services unless the services are in connection with
- 24 the construction of a specific facility to be jointly owned, used,
- 25 or financed by the parties to the contract or:
- 26 (1) the services are in connection with a job order
- 27 contract;

- 1 (2) the governing body of the governmental entity for
- 2 whom the work will ultimately be performed approves the purchase in
- 3 open session;
- 4 (3) public notice is provided in a manner consistent
- 5 with a direct contract for job order contracting services; and
- 6 (4) work orders under the contract comply with Section
- 7 2267.403.
- 8 SECTION 2.07. Section 2155.502(c), Government Code, is
- 9 amended to read as follows:
- 10 (c) The commission may not list a multiple award contract on
- 11 a schedule developed under Subsection (a) if the goods or services
- 12 provided by that contract:
- 13 (1) are available from only one vendor;
- 14 (2) are telecommunications services, facilities, or
- 15 equipment; [<del>or</del>]
- 16 (3) are commodity items as defined by Section
- 17 2157.068(a); or
- 18 (4) are engineering services as described by Section
- 19 1001.003, Occupations Code, or architectural services as described
- 20 by Section 1051.001, Occupations Code.
- 21 SECTION 2.08. Section 2166.2525, Government Code, is
- 22 amended to read as follows:
- Sec. 2166.2525. DETERMINATION OF CONTRACTING METHOD. The
- 24 [commission shall adopt rules that determine the circumstances for
- 25 use of each] method of contracting allowed under this subchapter
- 26 for design and construction services is any method provided by
- 27 Chapter 2267. [In developing the rules, the commission shall

- 1 solicit advice and comment from design and construction
- 2 professionals regarding the criteria the commission will use in
- 3 determining which contracting method is best suited for a project.
- 4 SECTION 2.09. Subtitle F, Title 10, Government Code, is
- 5 amended by adding Chapter 2267 to read as follows:
- 6 CHAPTER 2267. CONTRACTING AND DELIVERY PROCEDURES FOR
- 7 CONSTRUCTION PROJECTS
- 8 <u>SUBCHAPTER A. GENERAL PROVISIONS</u>
- 9 Sec. 2267.001. DEFINITIONS. In this chapter:
- 10 <u>(1) "Architect" means an individual registered as an</u>
- 11 architect under Chapter 1051, Occupations Code.
- 12 (2) "Engineer" means an individual licensed as an
- 13 <u>engineer under Chapter 1001, Occupations Code.</u>
- 14 (3) "Facility" means, unless otherwise specifically
- 15 provided, an improvement to real property.
- 16 (4) "General conditions" in the context of a contract
- 17 for the construction, rehabilitation, alteration, or repair of a
- 18 facility means on-site management, administrative personnel,
- 19 insurance, bonds, equipment, utilities, and incidental work,
- 20 including minor field labor and materials.
- 21 (5) "General contractor" means a sole proprietorship,
- 22 partnership, corporation, or other legal entity that assumes the
- 23 risk for constructing, rehabilitating, altering, or repairing all
- 24 or part of a facility at the contracted price.
- 25 (6) "Public work contract" means a contract for
- 26 constructing, altering, or repairing a public building or carrying
- 27 out or completing any public work.

Sec. 2267.002. APPLICABILITY OF CHAPTER TO GOVERNMENTAL 1 ENTITIES AND QUASI-GOVERNMENTAL ENTITIES ENGAGED IN PUBLIC WORKS. 2 This chapter applies to a public work contract made by a 3 governmental entity or quasi-governmental entity authorized by 4 5 state law to make a public work contract, including: 6 (1) a state agency as defined by Section 2151.002, 7 including the Texas Facilities Commission; 8 (2) a local government, including: (A) a county; 9 10 (B) a municipality; 11 (C) a school district; 12 (D) any other special district or authority, including a hospital district, a defense base development authority 13 established under Chapter 379B, Local Government Code, and a 14 15 conservation and reclamation district, including a river authority or any other type of water district; and 16 17 (E) any other political subdivision of this state; 18 19 (3) a public junior college as defined by Section 61.003, Education Code; 20 21 (4) any entity owned by a municipality; 22 (5) a board of trustees governed by Chapter 54, Transportation Code; and 23 24 (6) any other entity that owns or operates a facility for the benefit of <u>a municipality or county.</u> 25

PROCEDURES OF THIS CHAPTER. (a) Except as provided by this

- 1 section, this chapter prevails over any other law relating to a
- 2 public work contract.
- 3 (b) This chapter does not prevail over a conflicting
- 4 provision in a law relating to contracting with a historically
- 5 underutilized business.
- 6 (c) This chapter does not prevail over a conflicting
- 7 provision in an ordinance or resolution passed by the governing
- 8 body of a municipally owned electric utility in a procedure
- 9 described by Section 252.022(c), Local Government Code, that:
- 10 (1) requires the use of competitive bidding or
- 11 competitive sealed proposals; or
- 12 (2) prescribes a design-build procurement procedure
- 13 that conflicts with this chapter.
- 14 Sec. 2267.004. EXEMPTION: TEXAS DEPARTMENT OF
- 15 TRANSPORTATION; HIGHWAY PROJECTS. This chapter does not apply to:
- 16 (1) a contract entered into by the Texas Department of
- 17 Transportation; or
- 18 (2) a project that receives money from a state or
- 19 federal highway fund.
- 20 Sec. 2267.005. APPLICABILITY: INSTITUTIONS OF HIGHER
- 21 EDUCATION. (a) In this section, "institution of higher
- 22 education," "public junior college," and "university system" have
- 23 the meanings assigned by Section 61.003, Education Code.
- 24 (b) This chapter applies to a public junior college but does
- 25 not apply to:
- 26 (1) any other institution of higher education; or
- 27 (2) a university system.

- 1 Sec. 2267.006. EXEMPTION: REGIONAL TOLLWAY AUTHORITIES.
- 2 This chapter does not apply to a regional tollway authority under
- 3 Chapter 366, Transportation Code.
- 4 [Sections 2267.007-2267.050 reserved for expansion]
- 5 SUBCHAPTER B. GENERAL POWERS AND DUTIES
- 6 Sec. 2267.051. RULES. A governmental entity may adopt
- 7 <u>rules as necessary to implement this chapter.</u>
- 8 Sec. 2267.052. NOTICE REQUIREMENTS. (a) A governmental
- 9 entity shall advertise or publish notice of requests for bids,
- 10 proposals, or qualifications in a manner prescribed by law.
- 11 (b) For a contract entered into by a governmental entity
- 12 under a method provided by this chapter, the governmental entity
- 13 shall publish notice of the time and place the bid or proposal or
- 14 request for qualifications will be received and opened in a manner

If there 6 7 is not a newspaper of general circulation in that county, the notice 8 shall be published in a newspaper of general circulation in the county nearest the county seat of the county in which the defense 9 municipality's central 10 base development authority's or administrative office is located or the county in which the 11 12 greatest amount of the river authority's or such conservation and reclamation district's territory is located. In a two-step 13 procurement process, the time and place the second step bids, 14 proposals, or responses will be received are not required to be 15 16 published separately.
- 17 (d) For a contract entered into by a county under any of the methods provided by this chapter, the county shall publish notice 18 19 of the time and place the bids or proposals, or the responses to a request for qualifications, will be received and opened. The 20 notice must be published in a newspaper of general circulation in 21 22 the county once each week for at least two weeks before the deadline for receiving bids, proposals, or responses. If there is not a 23 24 newspaper of general circulation in the county, the notice shall 25 be:
- 26 (1) posted at the courthouse door of the county; and
- 27 (2) published in a newspaper of general circulation in

- 1 the nearest county.
- 2 Sec. 2267.053. DELEGATION OF AUTHORITY. (a) The governing
- 3 body of a governmental entity may delegate its authority under this
- 4 chapter regarding an action authorized or required by this chapter
- 5 to a designated representative, committee, or other person.
- 6 (b) The governmental entity shall provide notice of the
- 7 delegation, the limits of the delegation, and the name or title of
- 8 each person designated under Subsection (a) by rule or in the
- 9 request for bids, proposals, or qualifications or in an addendum to
- 10 the request.
- Sec. 2267.054. RIGHT TO WORK. (a) This section applies to
- 12 a governmental entity when the governmental entity is engaged in:
- 13 (1) procuring goods or services under this chapter;
- 14 (2) awarding a contract under this chapter; or
- 15 (3) overseeing procurement or construction for a
- 16 public work or public improvement under this chapter.
- 17 (b) In engaging in an activity to which this section
- 18 applies, a governmental entity:
- 19 (1) may not consider whether a person is a member of or
- 20 has another relationship with any organization; and
- 21 (2) shall ensure that its bid specifications and any
- 22 subsequent contract or other agreement do not deny or diminish the
- 23 right of a person to work because of the person's membership or
- 24 other relationship status with respect to an organization.
- 25 Sec. 2267.055. CRITERIA TO CONSIDER. (a) In determining
- 26 the award of a contract under this chapter, the governmental entity
- 27 may consider:

1 (1) the price; 2 the offeror's experience and reputation; 3 (3) the quality of the offeror's goods or services; 4 (4) the impact on the ability of the governmental 5 entity to comply with rules relating to historically underutilized 6 businesses; 7 (5) the offeror's safety record; 8 (6) the offeror's proposed personnel; (7) whether the offeror's financial capability is 9 10 appropriate to the size and scope of the project; and 11 (8) any other relevant factor specifically listed in 12 the request for bids, proposals, or qualifications. (b) In determining the award of a contract under this 13 14 chapter, the governmental entity shall: 15 (1) consider and apply any existing laws, including any criteria, related to historically underutilized businesses; 16 17 and (2) consider and apply any existing laws, rules, or 18 19 applicable municipal charters, including laws applicable to local governments, related to the use of women, minority, small, or 20 disadvantaged businesses. 21 Sec. 2267.056. USING METHOD OTHER THAN COMPETITIVE BIDDING 22 FOR CONSTRUCTION SERVICES; EVALUATION OF PROPOSALS; CRITERIA. 23 24 (a) The governing body of a governmental entity that considers a construction contract using a method authorized by this chapter 25 26 other than competitive bidding must, before advertising, determine which method provides the best value for the governmental entity. 27

- 1 (b) The governmental entity shall base its selection among
- 2 offerors on applicable criteria listed for the particular method
- 3 used. The governmental entity shall publish in the request for
- 4 proposals or qualifications the criteria that will be used to
- 5 evaluate the offerors, and the applicable weighted value for each
- 6 criterion.
- 7 (c) The governmental entity shall document the basis of its
- 8 selection and shall make the evaluations public not later than the
- 9 seventh day after the date the contract is awarded.
- 10 <u>Sec. 2267.057. ARCHITECT OR ENGINEER SERVICES. (a) An</u>
- 11 architect or engineer required to be selected or designated under
- 12 this chapter has full responsibility for complying with Chapter
- 13 1051 or 1001, Occupations Code, as applicable.
- 14 (b) If the selected or designated architect or engineer is
- 15 not a full-time employee of the governmental entity, the
- 16 governmental entity shall select the architect or engineer on the
- 17 basis of demonstrated competence and qualifications as provided by
- 18 Section 2254.004.
- 19 Sec. 2267.058. USE OF OTHER PROFESSIONAL SERVICES.
- 20 (a) Independently of the contractor, construction
- 21 manager-at-risk, or design-build firm, the governmental entity
- 22 shall provide or contract for the construction materials
- 23 engineering, testing, and inspection services and the verification
- 24 testing services necessary for acceptance of the facility by the
- 25 governmental entity.
- 26 (b) The governmental entity shall select the services for
- 27 which it contracts under this section in accordance with Section

- 2 Sec. 2267.059. SEALED BIDS, PROPOSALS, OR QUALIFICATIONS
- 3 REQUIRED. A person who submits a bid, proposal, or qualification to
- 4 a governmental entity shall seal it before delivery.
- 5 [Sections 2267.060-2267.100 reserved for expansion]
- 6 SUBCHAPTER C. COMPETITIVE BIDDING METHOD
- 7 Sec. 2267.101. CONTRACTS FOR FACILITIES: COMPETITIVE
- 8 BIDDING. (a) In this chapter, "competitive bidding" is a
- 9 procurement method by which a governmental entity contracts with a
- 10 contractor for the construction, alteration, rehabilitation, or
- 11 repair of a facility by awarding the contract to the lowest
- 12 responsible bidder.
- 13 (b) Except as otherwise provided by this chapter or other
- 14 law, a governmental entity may contract for the construction,
- 15 alteration, rehabilitation, or repair of a facility only after the
- 16 entity advertises for bids for the contract in a manner prescribed
- 17 by law, receives competitive bids, and awards the contract to the
- 18 lowest responsible bidder.
- 19 Sec. 2267.102. USE OF ARCHITECT OR ENGINEER. The
- 20 governmental entity shall select or designate an architect or
- 21 engineer in accordance with Chapter 1051 or 1001, Occupations Code,
- 22 as applicable, to prepare the construction documents required for a
- 23 project to be awarded by competitive bidding.
- Sec. 2267.103. PREPARATION OF REQUEST. The governmental
- 25 entity shall prepare a request for competitive bids that includes
- 26 construction documents, estimated budget, project scope, estimated
- 27 project completion date, and other information that a contractor

- 1 may require to submit a bid.
- 2 Sec. 2267.104. EVALUATION OF OFFERORS. The governmental
- 3 entity shall receive, publicly open, and read aloud the names of the
- 4 offerors and their bids.
- 5 Sec. 2267.105. SELECTION OF OFFEROR. Not later than the
- 6 seventh day after the date the contract is awarded, the
- 7 governmental entity shall document the basis of its selection and
- 8 shall make the evaluations public.
- 9 Sec. 2267.106. APPLICABILITY OF OTHER COMPETITIVE BIDDING
