A baked good does not include a 12 potentially hazardous food item as defined by department rule. 13 14 (2-b) "Cottage food production operation" means an individual, operating out of the individual's home, who: 15 16 (A) produces a baked good, a canned jam or jelly, or a dried herb or herb mix for sale at the person's home or a 17 farmers' market; 18 (B) has an annual gross income of \$50,000 or less 19 from the sale of food described by Paragraph (A); and 20 21 (C) sells the foods produced under Paragraph (A) 22 only directly to consumers. 23 (3) "Department" means the [Texas] Department of State 24 Health Services.

(3-a) "Executive commissioner" means the executive 1 2 commissioner of the Health and Human Services Commission. (5) "Home" means a primary residence that contains a 3 kitchen and appliances designed for common residential usage. 4 5 SECTION 2. Chapter 437, Health and Safety Code, is amended by adding Sections 437.0191 and 437.0192 to read as follows: 6 Sec. 437.0191. EXEMPTION FOR COTTAGE FOOD PRODUCTION 7 OPERATIONS.
