A BILL TO BE ENTITLED

1 AN ACT

- 2 relating to inspection of and the operation of watercraft on the
- 3 John Graves Scenic Riverway; providing for the imposition of a

- 5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 6 SECTION 1. Subsection (b), Section 26.555, Water Code, is
- 7 amended to read as follows:
- 8 (b) A [The] visual inspection from an aircraft flying over
- 9 the John Graves Scenic Riverway [inspections and the drawing of
- 10 water samples] must be conducted at least once in a winter month and
- 11 at least once in a summer month. \underline{A} [The] visual inspection and the
- 12 <u>drawing of water samples for testing</u> [<u>inspections</u>] must be
- 13 conducted [both] from the surface of the [John Graves Scenic
- 14 Riverway and from an aircraft flying over the] riverway at least
- 15 once in a spring month and at least once in a fall month.
- 16 SECTION 2. Subchapter M, Chapter 26, Water Code, is amended
- 17 by adding Section 26.563 to read as follows:
- 18 <u>Sec. 26.563. CERTAIN CRAFT PROHIBITED. (a) The commission</u>
- 19 by rule shall prohibit the commercial or recreational use of the
- 20 <u>following craft on the waters of the John Graves Scenic Riverway:</u>
- (1) airboats, fanboats, and similar shallow draft
- 22 watercraft that use an aircraft-type propeller for propulsion; and
- 23 (2) hovercraft.
- 24 (b) A rule adopted under this section must allow for the

- 1 operation of craft described by Subsection (a) for:
- 2 (1) a visual inspection conducted under Section
- 3 <u>26.555;</u> or
- 4 (2) law enforcement purposes.
- 5 (c) A person who operates a hovercraft or watercraft in
- 6 violation of a rule adopted under this section commits an offense.
- 7 An offense under this section is a Class C misdemeanor. Any peace
- 8 officer, including a law enforcement officer commissioned by the
- 9 Parks and Wildlife Commission, may enforce this section.
- 10 SECTION 3. This Act takes effect immediately if it receives
- 11 a vote of two-thirds of all the members elected to each house, as
- 12 provided by Section 39, Article III, Texas Constitution. If this
- 13 Act does not receive the vote necessary for immediate effect, this
- 14 Act takes effect September 1, 2011.
