S.B. No. 652

A BILL TO BE ENTITLED

AN ACT

relating to governmental entities subject to the sunset review process.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

ARTICLE 1. ENTITIES GIVEN 2013 SUNSET DATE

SECTION 1.01. GUARDIANSHIP CERTIFICATION BOARD. Section 111.003, Government Code, is amended to read as follows:

Sec. 111.003. SUNSET PROVISION. The board is subject to Chapter 325, Government Code (Texas Sunset Act). Unless continued in existence as provided by that chapter, the board is abolished and this chapter expires September 1, 2013 [~~2015~~].

SECTION 1.02. INTERAGENCY TASK FORCE FOR CHILDREN WITH SPECIAL NEEDS. Section 115.012, Health and Safety Code, as added by Chapters 835 (S.B. 1824) and 1133 (H.B. 2196), Acts of the 81st Legislature, Regular Session, 2009, is amended to read as follows:

Sec. 115.012. SUNSET PROVISION. The Interagency Task Force for Children With Special Needs is subject to Chapter 325, Government Code (Texas Sunset Act). Unless continued in existence as provided by that chapter, the task force is abolished and this chapter expires September 1, 2013 [~~2015~~].

ARTICLE 2. ENTITIES GIVEN 2019 SUNSET DATE

SECTION 2.01. LICENSED COURT INTERPRETER ADVISORY BOARD. Section 57.051, Government Code, is amended to read as follows:

Sec. 57.051. SUNSET. The licensed court interpreter

1 advisory board is subject to Chapter 325, Government Code (Texas
2 Sunset Act). Unless continued in existence as provided by that
3 chapter, the board is abolished and this subchapter expires
4 September 1, 2019 [~~2013~~].

5 ARTICLE 3. ENTITIES REMOVED FROM SPECIFIC SUNSET REVIEW

6 SECTION 3.01. BOARD OF DIRECTORS OF THE OFFICIAL CITRUS
7 PRODUCERS' PEST AND DISEASE MANAGEMENT CORPORATION. Section
8 80.028, Agriculture Code, is amended to read as follows:

9 Sec. 80.028. DISSOLUTION [~~SUNSET~~] PROVISION. (a) [~~The~~
10 ~~board of directors of the official citrus producers' pest and~~
11 ~~disease management corporation is subject to Chapter 325,~~
12 ~~Government Code (Texas Sunset Act). Unless continued in existence~~
13 ~~as provided by that chapter, the board is abolished and this chapter~~
14 ~~expires September 1, 2021.~~

15 [~~(b)~~] The commissioner may order the dissolution of the
16 corporation at any time the commissioner determines that the
17 purposes of this chapter have been fulfilled or that the
18 corporation is inoperative and abandoned. Dissolution shall be
19 conducted in accordance with Section 80.014.

20 (b) [~~(c)~~] If the corporation [~~is abolished~~] or the
21 suppression program is discontinued for any reason, assessments
22 approved, levied, or otherwise collectible on the date of
23 discontinuance [~~abolishment~~] remain valid as necessary to pay the
24 financial obligations of the corporation.

25 ARTICLE 4. EFFECTIVE DATE

26 SECTION 4.01. EFFECTIVE DATE. This Act takes effect
