- 3 Water Improvement District No. 3.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. DEFINITIONS. In this Act:
- 6 (1) "City" means a municipality described by Section 2 7 of this Act.
- 8 (2) "City council" means the governing body of a city.
- 9 (3) "District" means the Hidalgo County Water
- 10 Improvement District No. 3.
- 11 (4) "District board" means the district's board of
- 12 directors.

- 13 SECTION 2. DISTRICT AND MUNICIPALITY TO WHICH ACT IS
- 14 APPLICABLE. This Act applies only to:
- 15 (1) the district; and
- 16 (2) a municipality that:
- 17 (A) has a population greater than 100,000; and
- 18 (B) contains within its corporate boundaries or
- 19 extraterritorial jurisdiction more than half of the district's
- 20 territory.
- 21 SECTION 3. FINDINGS PREREQUISITE TO MOTION TO DISSOLVE. At
- 22 a regularly scheduled meeting of the city council, a city may
- 23 propose an ordinance to dissolve the district if the city council
- 24 finds that as of the date of the meeting:

- 1 (1) at least 80 percent of the raw water diverted by
- 2 the district in the preceding 12 months was diverted for use by the
- 3 city;
- 4 (2) the city is capable of assuming all rights and
- 5 obligations of the district;
- 6 (3) the city is capable of assuming responsibility for
- 7 operating the district's facilities to benefit the district's
- 8 existing customers and performing the services and functions
- 9 performed by the district;
- 10 (4) dissolution of the district will result in an
- 11 overall cost savings to city residents; and
- 12 (5) dissolution of the district will result in a more
- 13 stable water supply for residents of the city and surrounding
- 14 communities.
- 15 SECTION 4. HEARING REQUIRED. (a) Before a city may
- 16 propose an ordinance to dissolve the district, the city must
- 17 conduct a public hearing on the issue.
- 18 (b) Notice of the public hearing must be:
- 19 (1) posted in accordance with the laws that apply to
- 20 regular meetings of the city council; and
- 21 (2) provided in writing to each district board member.
- 22 SECTION 5. DISSOLUTION BY ORDINANCE. (a) After a city
- 23 council has made the findings required by Section 3 of this Act and
- 24 has conducted a public hearing as required by Section 4 of this Act,
- 25 the city council may dissolve the district by ordinance.
- 26 (b) The ordinance must contain provisions that:
- 27 (1) eliminate the required payment of any flat tax or

- 1 assessments paid to the district by landowners in the district;
- 2 (2) ensure that all water rights are held in trust by
- 3 the city for the uses previously adjudicated;
- 4 (3) ensure that all individual water users are
- 5 entitled to continue to use or have access to the same amount of
- 6 water they were entitled to before the dissolution of the district;
- 7 and
- 8 (4) ensure delivery of water to landowners at or below
- 9 the lowest comparable delivery charge imposed by any other
- 10 irrigation district in Hidalgo County.
- 11 (c) The ordinance takes effect only if two-thirds of the
- 12 city council votes in favor of the ordinance.
- 13 SECTION 6. CITY CONSENT; DISTRICT DUTIES. (a) On or
- 14 before the effective date of the dissolution ordinance, the
- 15 district board shall provide the district's management and
- 16 operational records to the city that passed the ordinance to ensure
- 17 the orderly transfer of management and operational responsibility
- 18 to the city.
- 19 (b) Without the consent of a majority of the members of a
- 20 city council that publishes notice under Section 4(b) of this Act,
- 21 the district may not:
- 22 (1) sell, transfer, or encumber any district asset;
- 23 (2) issue debt or acquire additional obligations; or
- 24 (3) default on or fail to honor financial, legal, or
- 25 other obligations of the district.
- 26 (c) Unless a majority of the members of a city council that
- 27 publishes notice under Section 4(b) of this Act agree otherwise,

- 1 the district shall:
- 2 (1) maintain assets of the district in an appropriate
- 3 condition reflective of good stewardship and proper repair; and
- 4 (2) preserve district records, including information
- 5 maintained by the district in electronic format.
- 6 (d) Any action undertaken by the district that does not
- 7 comply with Subsection (b) of this section is void.
- 8 (e) This section expires on the date a city that has
- 9 published notice under Section 4(b) of this Act repeals the city's
- 10 ordinance to dissolve the district.
- 11 SECTION 7. PETITION BY VOTERS; SUSPENSION OR REPEAL OF
- 12 ORDINANCE; ELECTION. (a) The voters of a city that enacts a
- 13 dissolution ordinance under this Act may object to the ordinance by
- 14 filing a petition with the secretary of the city. The petition must
- 15 be signed by at least five percent of the city's registered voters.
- 16 The petition must be filed not later than the 30th day after the
- 17 date the city enacts the ordinance.
- 18 (b) The city secretary shall verify the signatures on the
- 19 petition and shall present the verified petition to the city
- 20 council at the council's next scheduled meeting.
- 21 (c) On receipt of the petition, the city council shall
- 22 suspend the effectiveness of the ordinance, and the city may not
- 23 take action under the ordinance unless the ordinance is approved by
- 24 the voters under Subsection (d) of this section.
- 25 (d) The city council shall reconsider the suspended
- 26 ordinance at the next scheduled meeting of the council. If the city
- 27 council does not repeal the ordinance, the city council shall

- 1 submit a proposition for or against enactment of the ordinance to
- 2 the voters at the next municipal election. The dissolution
- 3 ordinance takes effect if a majority of the voters voting in that
- 4 election vote in favor of dissolution.
- 5 SECTION 8. EFFECTIVE DATE OF DISSOLUTION. A dissolution
- 6 ordinance under this Act takes effect on the date:
- 7 (1) the period for filing a voter petition expires
- 8 under Section 7(a) of this Act, if a voter petition is not filed
- 9 under that section; or
- 10 (2) the voters approve the dissolution ordinance under
- 11 Section 7(d) of this Act.
- 12 SECTION 9. TRANSFER OF ASSETS. (a) On or before the
- 13 effective date of a dissolution ordinance under Section 8 of this
- 14 Act, the district shall:
- 15 (1) transfer to the city the ownership of any water
- 16 rights and certificates of adjudication;
- 17 (2) transfer the assets, debts, and contractual rights
- 18 and obligations of the district to the city; and
- 19 (3) provide notice and make recordings of the
- 20 transfers under this section as required by the Water Code and other
- 21 law.
- (b) On receipt of notice of the transfer of a district
- 23 certificate of adjudication, the Texas Commission on Environmental
- 24 Quality shall note in its records that the certificate of
- 25 adjudication is owned and held by the city. The Texas Commission on
- 26 Environmental Quality shall transfer the district's certificate to
- 27 the city as a ministerial act without further application, notice,

- 1 or hearing. A person or other legal entity does not have a right to
- 2 object to or to request an administrative review of a transfer made
- 3 in accordance with this Act.
- 4 (c) The transfer of the district's water rights and any
- 5 certificate of adjudication to the city does not affect or impair
- 6 the priority, extent, validity, or purpose of the water rights or
- 7 certificate.
- 8 SECTION 10. EXPIRATION. This Act expires January 1, 2016.
- 9 SECTION 11. EFFECTIVE DATE. This Act takes effect
- 10 immediately if it receives a vote of two-thirds of all the members
- 11 elected to each house, as provided by Section 39, Article III, Texas
- 12 Constitution. If this Act does not receive the vote necessary for
- 13 immediate effect, this Act takes effect September 1, 2011.
