- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. Section 981.105, Insurance Code, is amended by
- 6 adding Subsections (c) through (i) to read as follows:
- 7 (c) The commissioner may assess a fee against an agent who
- 8 files a surplus lines policy after the filing deadline specified by
- 9 Subsection (a).
- 10 (d) For an agent who files a surplus lines policy on or
- 11 before the 180th day after the effective date or issue date
- 12 <u>described by Subsection (a), the amount of the fee is:</u>
- 13 (1) \$50 for each late-filed policy if, in the calendar
- 14 year immediately preceding the year in which the policy is
- 15 late-filed, the agent has filed not more than five percent of the
- 16 policies the agent was required to file after the filing deadline
- 17 specified by Subsection (a); or
- 18 (2) \$100 for each late-filed policy if, in the
- 19 <u>calendar year immediately preceding the year in which the policy is</u>
- 20 <u>late-filed</u>, the agent has filed more than five percent of the
- 21 policies the agent was required to file after the filing deadline
- 22 specified by Subsection (a).
- (e) For an agent who files a surplus lines policy after the
- 24 180th day but before the 365th day after the effective date or issue

- 1 date described by Subsection (a) and who, during the immediately
- 2 preceding calendar year, filed not more than two percent of the
- 3 policies the agent was required to file after the filing deadline
- 4 specified by Subsection (a), the amount of the fee for the
- 5 <u>late-filed policy is \$200.</u>
- 6 (f) Notwithstanding any other provision of this section,
- 7 for an agent who not later than January 1, 2012, files a late-filed
- 8 policy with an effective date before January 1, 2010, that, at the
- 9 time the policy is filed, has not been listed in a previous
- 10 late-filed policy report of the stamping office, the amount of the
- 11 fee is \$50 for each late-filed policy.
- 12 (g) The assessment, imposition, or payment of a fee under
- 13 this section does not establish a violation for purposes of Section
- 14 81.004, 82.051, 82.052, 82.054, 82.056, or 84.022(b)(3).
- 15 (h) An agent who files a surplus lines policy after the
- 16 filing deadline specified by Subsection (a) is subject to Chapters
- 17 <u>81, 82, and 84 only if the agent:</u>
- 18 (1) fails to timely pay a fee assessed under this
- 19 section;
- 20 (2) files a surplus lines policy on or after the 365th
- 21 day after the effective date or issue date; or
- 22 (3) files a surplus lines policy after the 180th day
- 23 but before the 365th day of the effective date or issue date, and in
- 24 the calendar year immediately preceding the year in which the
- 25 policy is late-filed, filed more than two percent of the policies
- 26 the agent was required to file after the filing deadline specified

- 1 (i) The department shall provide notice to each agent of the
- 2 amount of fees assessed under this section during each calendar

- 7 SECTION 2. (a) Except as provided by Subsection (b) of

- 21 (3) brought on or after the effective date of this Act
- 22 against a surplus lines agent for policies filed after the filing
- 23 deadline prescribed by Subsection (a), Section 981.105, Insurance
- 24 Code, and filed during the 2011 calendar year.
- 25 (c) Not later than December 1, 2011, the Texas Department of
- 26 Insurance shall provide notice to each surplus lines agent to which
- 27 Subdivisions (1) and (2) of Subsection (b) of this section apply of

- 1 the amount of fees assessed. The surplus lines agent shall pay the
- 2 fee not later than the 30th day after the date of the notice.
- 3 (d) The notice and payment provisions described by
- 4 Subsection (i), Section 981.105, Insurance Code, as added by this
- 5 Act, apply to policies filed during or after the 2011 calendar year.
- 6 SECTION 3. This Act takes effect immediately if it receives
- 7 a vote of two-thirds of all the members elected to each house, as
- 8 provided by Section 39, Article III, Texas Constitution. If this
- 9 Act does not receive the vote necessary for immediate effect, this
- 10 Act takes effect September 1, 2011.
