The chair laid out the list of bills recommended for placement on the Local and Uncontested Calendar to be held April 7, 2011, at 8:00 AM. The committee recommended the removal of SB 899, SB 990, SB 1034, and SB 1187, which passed on the intent calendar; SB 534, SB 765, and SB 815, which were withdrawn by the authors; and SB 285 and SB 501.

a vote of 7 ayes, 0 nays, 0 present not voting, and 0 absent. Senator Wentworth requested unanimous consent to be shown voting aye on the bills recommended for placement on the Local and Uncontested Calendar to be held April 7, 2011, with a motion in writing.

The chair laid out as a matter of pending business SB 1338 and recognized the author, Senator Eltife, to explain the bill.
