A BILL TO BE ENTITLED

AN ACT

2 relating to the preference given by state agencies to goods offered 3 by bidders in this state or manufactured, produced, or grown in this 4 state or in the United States.

5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
6 SECTION 1. Sections 2155.444(a), (b), and (c), Government

7 Code, are amended to read as follows:

8 (a) The <u>comptroller</u> [commission] and all state agencies 9 making purchases of goods, including agricultural products, shall 10 <u>promote the purchase of and</u> give preference to <u>goods manufactured</u>, 11 [those] produced, or grown in this state or offered by Texas bidders 12 as follows:

(1) goods <u>manufactured</u>, produced, or offered by a Texas bidder that is owned by a service-disabled veteran who is a Texas resident shall be given a first preference and goods <u>manufactured or</u> produced in this state or offered by other Texas bidders shall be given second preference, if the cost to the state and quality are equal; and

19 (2) agricultural products grown in this state shall be
20 given first preference and agricultural products offered by Texas
21 bidders shall be given second preference, if the cost to the state
22 and quality are equal.

(b) If goods, including agricultural products,
24 <u>manufactured</u>, produced, or grown in this state or offered by Texas

bidders are not equal in cost and quality to other products, then goods, including agricultural products, <u>manufactured</u>, produced, or grown in other states of the United States shall be given preference over foreign products if the cost to the state and quality are equal.

(c) In this section:

7 (1) "Agricultural products" includes textiles and8 other similar products.

9 (2) "Manufactured" means, with respect to assembled 10 goods, the final assembly, processing, packaging, testing, or other 11 process that adds value, quality, or reliability.

12 (3) [(1-a)] "Service-disabled veteran" means a person 13 who is a veteran as defined by 38 U.S.C. Section 101(2) and who has a 14 service-connected disability as defined by 38 U.S.C. Section 15 101(16).

16 (4) [(2)] "Texas bidder" means a business:
17 (A) incorporated in this state;

18 (B) that has its principal place of business in19 this state; or

20 (C) that has an established physical presence in21 this state.

SECTION 2. The change in law made by this Act applies only to a contract for goods that is entered into on or after the effective date of this Act. A contract entered into before the effective date of this Act is governed by the law in effect on the date the contract was entered into, and the former law is continued in effect for that purpose.
