14	(1) four members of the senate, including members from
15	different political parties, appointed by the lieutenant governor
16	based on seniority;
17	(2) four members of the house of representatives,
18	including members from different political parties, appointed by
19	the speaker of the house of representatives based on seniority;
20	(3) a representative of a nonprofit or charitable
21	organization appointed by the governor;
22	(4) a representative of an advocacy organization
23	focused on state and federal fiscal matters appointed by the

3	(6) a representative of the comptroller's office,
4	appointed by the comptroller.
5	(b) The committee shall elect a presiding officer from among
6	its members.
7	Sec. 2116.003. COMPENSATION. A committee member serves
8	without compensation but is entitled to reimbursement for actual
9	and necessary expenses incurred in performing functions as a
10	committee member, subject to any applicable limitation on
11	reimbursement provided by general law or the General Appropriations
12	<u>Act.</u>
13	Sec. 2116.004. COMMITTEE DUTIES. The committee shall:
14	(1) meet at the call of the presiding officer;
15	(2) conduct a study on:
16	(A) the percentage of the state budget that is
17	funded by federal money; and
18	(B) the effects on the state budget if federal
19	fiscal policy necessitates a significant reduction in or
20	elimination of federal funding for state governments; and
21	(3) create a plan to address the loss of federal money,
22	including federal Medicaid matching money and federal social
23	security payments, and maintain benefit programs and other
24	essential state services if federal fiscal policy necessitates a
25	significant reduction in or elimination of federal funding for
26	state governments.
27	Sec. 2116.005. REPORT. Not later than September 1, 2014,

## 1 the committee shall submit a report based on its findings to:

- 2 (1) the governor;
- 3 (2) the lieutenant governor; and

4 (3) the speaker of the house of representatives.

5 <u>Sec. 2116.006. EXPIRATION. This chapter expires and the</u> 6 committee is abolished December 1, 2014.

7 SECTION 2. (a) Not later than October 1, 2013, the 8 lieutenant governor, the speaker of the house of representatives, 9 the governor, the comptroller of public accounts, and the Legislative Budget Board shall make the appointments 10 and designations required by Section 2116.002(a), Government Code, as 11 added by this Act. 12

(b) Not later than November 1, 2013, the governor shall call the first meeting of the Select Committee on Budget Dependence on Federal Funding to permit the committee to elect a presiding officer as required by Section 2116.002(b), Government Code, as added by this Act.
