BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

1-19 SECTION 1. Section 8132.003, Special District Local Laws 1-20 Code, is amended to read as follows:

Sec. 8132.003. CONFIRMATION ELECTION REQUIRED. 1-21 If the 1-22 1-23 creation of the district is not confirmed at a confirm election held under Section 8132.023 before September 1, confirmed at a confirmation 2017 1-24  $[\frac{2013}{2}]$ :

1-25 (1)the district is dissolved September 1, 2017 1-26 [2013], except that:

(A) any debts incurred shall be paid;

1-27 1-28 (B) any assets that remain after the payment of debts shall be transferred to Williamson County; and 1-29

(C) the organization of the district shall be maintained until all debts are paid and remaining assets are 1-30 1-31 1-32 transferred; and 1-33

(2) this chapter expires September 1, 2020 [2016].

SECTION 2. Section 8132.025, Special District Local Laws 1-34 1-35 Code, is amended to read as follows:

Sec. 8132.025. EXPIRATION OF SUBCHAPTER. This subchapter expires September 1, 2020, unless the creation of the district is confirmed at a confirmation election held under Section 8132.023 1-36 1-37 1-38 1-39

<u>before September 1, 2017 [2016]</u>. <u>SECTION 3. (a)</u> The legal notice of the intention to introduce this Act, setting forth the general substance of this Act, has been published as provided by law, and the notice and a copy of this Act have been furnished to all persons, agencies, officials, or entities to which they are required to be furnished under Section 50. Article XVI. Texas Constitution, and Chapter 313 1-40 1-41 1-42 1-43 1-44 under Section 59, Article XVI, Texas Constitution, and Chapter 313, 1-45 1-46 Government Code.
