A BILL TO BE ENTITLED

- 2 relating to comprehensive development agreements of the Texas

- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. Section 223.201, Transportation Code, is amended
- 6 by amending Subsections (a), (b), (f), (g), (i), (j), (k), and (l)
- 7 and adding Subsection (j-1) to read as follows:
- 8 (a) Subject to Section 223.202, the department may enter
- 9 into a comprehensive development agreement with a private entity to
- 10 design, develop, finance, construct, maintain, repair, operate,
- 11 extend, or expand a:
- 12 (1) toll project;
- 13 (2) state highway improvement project that includes
- 14 both tolled and nontolled lanes and may include nontolled
- 15 appurtenant facilities;
- 16 (3) state highway improvement project in which the
- 17 private entity has an interest in the project; [or]
- 18 (4) state highway improvement project financed wholly
- 19 or partly with the proceeds of private activity bonds, as defined by
- 20 Section 141(a), Internal Revenue Code of 1986; or
- 21 (5) nontolled state highway improvement project
- 22 authorized by the legislature.
- 23 (b) In this subchapter, "comprehensive development
- 24 agreement" means an agreement that, at a minimum, provides for the

- 6 into a comprehensive development agreement for:
- 7 (1) the Hidalgo County Loop Project;
- 8 (2) the International Bridge Trade Corridor
- 9 Project; and
- 10 (3) projects associated with commuter rail.
- 11 SECTION 4. Section 371.101, Transportation Code, is amended
- 12 to read as follows:
- 13 Sec. 371.101. TERMINATION FOR CONVENIENCE. (a) \underline{A}
- 14 comprehensive development agreement under which a private
- 15 participant receives the right to operate and collect revenue from
- 16 <u>a toll project must contain a provision authorizing the toll</u>
- 17 project entity to terminate the agreement for convenience and to
- 18 purchase, under terms agreed to by the parties:
- 19 (1) the interest of the private participant in the
- 20 comprehensive development agreement; and
- 21 (2) related property, including any interest in a
- 22 highway or other facility designed, developed, financed,
- 23 constructed, operated, or maintained under the agreement.
- 24 (b) A comprehensive development agreement described by
- 25 Subsection (a) must include a price breakdown stating a specific
- 26 price for the purchase of the private participant's interest at
- 27 specified intervals from the date the toll project opens, of not

- 1 less than two years and not more than five years, over the term of
- 2 the agreement.
- 3 (c) The provision must authorize the toll project entity to
- 4 terminate the comprehensive development agreement and to purchase
- 5 the private participant's interest at any time during a specified
- 6 interval at the lesser of:
- 7 (1) the price stated for that interval; or
- 8 (2) the greater of:
- 9 (A) the then fair market value of the private
- 10 participant's interest, plus or minus any other amounts specified
- in the comprehensive development agreement; or
- 12 (B) an amount equal to the amount of outstanding
- 13 debt specified in the comprehensive development agreement, plus or
- 14 minus any other amounts specified in the comprehensive development
- 15 <u>agreement</u>.
- 16 (d) A toll project entity shall include in a request for
- 17 proposals for an agreement described by Subsection (a) a request
- 18 for the proposed price breakdown described by Subsection (b) and
- 19 shall assign points to and score each proposer's price breakdown in
- 20 the evaluation of proposals.
- 21 (e) A private participant shall, not later than 12 months
- 22 <u>before the date that a new price interval takes effect, notify the</u>
- 23 toll project entity of the beginning of the price interval. The
- 24 toll project entity must notify the private participant as to
- 25 whether it will exercise the option to purchase under this section
- 26 not later than six months after the date it receives notice under
- 27 this subsection.

- 1 <u>(f) A toll project entity must notify the private</u> 2 participant of the toll project entity's intention to purchase the
- 3 private participant's interest under this section not less than six
- 4 months before the date of the purchase.
- 5 (g) Subsections (b), (c), (d), (e), and (f) do not apply to a
- 6 project for which a request for proposals was issued before January
- 7 1, 2013.
- 8 (h) If a project requires expansion or reconstruction in a
- 9 manner that differs from the manner provided in the original
- 10 project scope or schedule, the price for terminating the
- 11 comprehensive development agreement may be adjusted to reflect the
- 12 changes in the agreement. [A toll project entity having rulemaking
- 13 authority by rule and a toll project entity without rulemaking
- 14 authority by official action shall develop a formula for making
- 15 termination payments to terminate a comprehensive development
- 16 agreement under which a private participant receives the right to
- 17 operate and collect revenue from a toll project. A formula must
- 18 calculate an estimated amount of loss to the private participant as
- 19 a result of the termination for convenience.
- 20 [(b) The formula shall be based on investments,
- 21 expenditures, and the internal rate of return on equity under the
- 22 agreed base case financial model as projected over the original
- 23 term of the agreement, plus an agreed percentage markup on that
- 24 amount.
- 25 [(c) A formula under Subsection (b) may not include any
- 26 estimate of future revenue from the project, if not included in an
- 27 agreed base case financial model under Subsection (b).

- 1 Compensation to the private participant upon termination for
- 2 convenience may not exceed the amount determined using the formula
- 3 under Subsection (b).
- 4 SECTION 5. This Act takes effect immediately if it receives
- 5 a vote of two-thirds of all the members elected to each house, as
- 6 provided by Section 39, Article III, Texas Constitution. If this
- 7 Act does not receive the vote necessary for immediate effect, this
- 8 Act takes effect September 1, 2013.
