(a) For purposes of this section: (1) "Campus" means all land and buildings owned or 11 leased by an institution of higher education or private or 12 13 independent institution of higher education. 14 (2) "Institution of higher education" and "private or independent institution of higher education" have the meanings 15 assigned by Section 61.003, Education Code. 16 17 (b) An institution of higher education or private or independent institution of higher education in this state may not 18 adopt or enforce any rule, regulation, or other provision or take 19 any other action, including posting notice under Section 30.06, 20 Penal Code, prohibiting or placing restrictions on the storage or 21 22 transportation of a firearm or ammunition in a locked, privately owned or leased motor vehicle by a person, including a student 23 24 enrolled at that institution, who holds a license to carry a
