#### "CONSIDERATION AND APPROVAL OF A RESOLUTION SUPPORTING THE UNIVERSITY OF TEXAS BOARD OF REGENTS EFFORTS TO ESTABLISH A VALLEYWIDE EMERGING RESEARCH FACILITY AND MEDICAL SCHOOL IN THE RIO GRANDE VALLEY."

- WHEREAS, on December 6, 2012, the Chancellor of the University of Texas, Dr. Francisco G. Cigarroa proposed an initiative to the University of Texas System Board of Regents to establish a new university that includes the University of Texas at Brownsville, the University of Texas-Pan American and the future South Texas School of Medicine; and
- WHEREAS, the Board of Regents unanimously approved this initiative which would result in a single institution that spans the entire Rio Grande Valley, with a presence in each of the major metropolitan areas of Brownsville, Edinburg, Harlingen and McAllen; and
- WHEREAS, the Board of Regents also approved the allocation of \$100 million over the next 10 years to accelerate the pace of transitioning the Regional Academic Health Center in Harlingen to a school of medicine; and
- WHEREAS, if approved by the Texas legislature it would make this new institution eligible for revenue from Permanent University Fund (PUF) – a major catalyst for building a world class research facility of higher learning complemented with a school of medicine for the entire Rio Grande Valley; and
- WHEREAS, the plan proposed and approved would result in a single institution spanning the Rio Grande valley with a presence in each of the major metropolitan areas of Brownsville, Edinburg, Harlingen and McAllen; and
- WHEREAS, it is estimated that this initiative would spur economic growth and create over 10,000 jobs initially; and

- **WHEREAS,** the County Commissioners of Cameron County recognizes that this is one of the largest educational and economic development opportunities for our region; and
- WHEREAS, this Commissioner's Court wants to personally thank Chancellor Cigarroa and the Board of Regents for their vision to transform the educational landscape of the Rio Grande Valley and to allow our future generations an opportunity to succeed in a medical profession given the close proximity they will have to an illustrious institution like the University of Texas Medical School in South Texas.

**NOW, THEREFORE, BE IT RESOLVED** that the Cameron County Commissioners' Court unanimously expresses its strong support to establish a valley wide emerging research facility and a medical school in the Rio Grande Valley and respectfully requests that all elected leaders in Austin support this initiative which has been a priority of this body and has been at the forefront for many leaders in the region for many years.

On behalf of the Hispanic Association of Colleges and Universities (HACU), I am writing to urge your strong support of the proposed merger of the existing University of Texas at Brownsville and the University of Texas-Pan American into a new University of Texas institution in South Texas, which would also include a new school of medicine. HACU represents more than 400 colleges and universities, including 69 in Texas.

As you know, the Rio Grande Valley of this state is continuing to experience rapid population and economic growth even as higher educational opportunities have lagged. A merger of the Brownsville and Edinburg campuses would leverage the strengths of both, eliminate unnecessary duplications, and better meet the needs of all the residents of the region. The new University has the potential to become a major research institution and a driver of economic development and innovation in South Texas.

Moreover, the creation of a full-fledged medical school in the Valley is an urgent need. The health care needs of this region are dramatically underserved, with only 124 doctors for every 100,000 residents, far behind the state average of 165 doctors and little more than half the national average of 240 doctors per 100,000 residents. The existing UTHSC-San Antonio's Regional Academic Health Center already provides a solid foundation for the beginnings of the new medical school.

The work of the University of Texas System in preparing this proposal amply documents the economies of scale that will be realized by this merger and the educational and economic stimulus the new institution would provide to the region and to the State.

Your strong support for this proposal is critical to meeting the 21<sup>st</sup> century educational, medical and economic needs of this region and of the state of Texas. As the demography of Texas becomes increasingly Hispanic, more adequately addressing the educational needs of Hispanic students and of the Rio Grande Valley is vital to assuring the future of the state.

Whereas, the development of the new medical school will not only provide critically needed research and health care benefitting the growing South Texas population, but also complement developments in San Antonio such as the new children's hospital in San Antonio;

Whereas, what benefits this important, fast-growing region of Texas benefits the economic vitality of the entire State of Texas; now, therefore,

On behalf of the United States Hispanic Chamber of Commerce (USHCC), the country's largest Hispanic business organization, I am writing to urge your strong support of the proposed creation of a new university in south Texas, combining the existing University of Texas - Brownsville and the University of Texas-Pan American campuses, along with the medical school authorized by the legislature in 2009. Under the visionary leadership of Chancellor Francisco Cigarroa, a friend of the USHCC and strong ally of the Hispanic business community, the proposal offered by the University of Texas System to the legislature amply documents the educational and economic benefits the new institution would provide to the region and to the State – home to a large portion of Hispanic entrepreneurs, the fastest growing segment of American enterprise.
