HB 479 Harper-Brown Relating to the allocation to the state highway fund of certain revenue from the taxes imposed on the sale, rental, or use of motor vehicles.

HB 2100 Thompson, Senfronia | et al. Relating to the salary reclassification of certain positions with the Department of Public Safety of the State of Texas.

HB 2202 Pickett | et al. Relating to the disposition of fees collected by or on behalf of the Texas Department of Motor Vehicles; authorizing fees.

HB 2278 Phillips Relating to the state highway fund.

HB 2770 Branch Relating to the investment of certain money in the economic stabilization fund.

HB 3157 Harless Relating to taxes and fees wholly or partly deposited to the credit of the state highway fund; increasing the rates of the gasoline and diesel fuel taxes, authorizing the increase or decrease of those rates in subsequent years, and increasing motor vehicle registration fees.

HB 3579 Strama Relating to investment of the economic stabilization fund.

HB 3640 Pitts Relating to the creation of an extension center of the Texas State Technical College System.

HB 3660 Simmons Relating to the functions of the Texas Commission on Fire Protection.

HB 3664 Darby Relating to the allocation of the state highway fund; restricting the use of the state highway fund; increasing the fee for motor vehicle and trailer registration.

HB 3665 Darby Relating to the financing of transportation projects; authorizing fees.

HB 3666 Darby Relating to authorizing a public safety fee on compulsory inspection of a motor vehicle.

HB 3836 Harper-Brown Relating to the establishment of a motor vehicle mileage fee program for certain motor vehicles by the Texas Department of Motor Vehicles; authorizing a fee.

HJR 108 Phillips Proposing a constitutional amendment to limit the purposes for which revenue from motor vehicle registration fees, taxes on motor fuels and lubricants and motor vehicle tires and parts, and certain revenues received from the federal government may be used.

HJR 136 Harless

Proposing a constitutional amendment limiting the permissible uses of the state highway fund, including further limiting the use of additional tax and fee revenue attributable to changes to certain state taxes and fees, to increase revenue for nontolled public highway purposes.
