Relating to the confidentiality of certain records maintained by a victims of trafficking shelter center and the creation of minimum standards for certain facilities that provide services to victims of trafficking.

Relating to the adoption of new rules by state agencies.

Relating to the availability of the personal information of a legislator under the public information law.

HB 2934 Hunter
Relating to electronic communications during a public meeting and the definitions of public information and official business under the public information law; creating an offense.

HB 3195 Kolkhorst
Relating to the review of certain administrative hearings conducted by health and human services agencies.

HB 3369 Perry
Relating to the creation of the office of inspector general.

HB 3646 Harper-Brown
Relating to a governmental entity's selection of an advertising medium and publication of notice.

HB 3804 Branch
Relating to written electronic communications between members of a governmental body.

HB 3862 Harper-Brown
Relating to nonsubstantive additions to and corrections in enacted codes, to the nonsubstantive codification or disposition of various laws omitted from enacted codes, and to conforming codifications enacted by the 82nd Legislature to other Acts of that legislature.

HJR 99 Villarreal
Proposing a constitutional amendment providing for the issuance of general obligation bonds to finance pay-for-performance contracts for certain programs and services for health programs.

HJR 112 Laubenberg
Proposing a constitutional amendment limiting the authority of the state to collect, receive, or store certain consumer information.
