1-19 relating to member contributions to the Employees Retirement System  
 1-20 of Texas.

1-21 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

1-22 SECTION 1. Section 815.402(a), Government Code, is amended  
 1-23 to read as follows:

1-24 (a) Except as provided by Section 813.201, each payroll  
 1-25 period, each department or agency of the state shall cause to be  
 1-26 deducted from each member's compensation a contribution of:

1-27 (1) 9.5 [~~6.6 percent of the compensation if the member~~  
 1-28 ~~is not a member of the legislature, for service rendered after~~  
 1-29 ~~August 31, 2013, and before September 1, 2014;~~

1-30 [~~(2) 6.9 percent of the compensation if the member is~~  
 1-31 ~~not a member of the legislature, for service rendered after August~~  
 1-32 ~~31, 2014, and before September 1, 2015;~~

1-33 [~~(3) 7.2~~] percent of the compensation if the member is  
 1-34 not a member of the legislature, for service rendered after August  
 1-35 31, 2015, and before September 1, 2017 [~~2016~~];

1-36 (2) [~~(4) 7.5 percent of the compensation if the~~  
 1-37 ~~member is not a member of the legislature, for service rendered~~  
 1-38 ~~after August 31, 2016;~~

1-39 [~~(5)~~] for service by a member who is not a member of  
 1-40 the legislature rendered on or after September 1, 2017, the lesser  
 1-41 of:

1-42 (A) 9.5 [~~7.5~~] percent of the member's annual  
 1-43 compensation; or

1-44 (B) a percentage of the member's annual  
 1-45 compensation equal to 9.5 [~~7.5~~] percent reduced by one-tenth of one  
 1-46 percent for each one-tenth of one percent that the state  
 1-47 contribution rate for the fiscal year to which the service relates  
 1-48 is less than the state contribution rate established for the 2017  
 1-49 [~~2015~~] fiscal year; or

1-50 (3) 9.5 [~~(6) eight~~] percent of the compensation if the  
 1-51 member is a member of the legislature.
