A person described by Section 171.081, Health 20 and Safety Code, as added by this Act, who is hired, begins 21 volunteering, or begins providing services under contract before 22 September 1, 2015, is not required to comply with Section 171.082, 23 Health and Safety Code, as added by this Act, before September 1, 24 2016.

25 SECTION 4. This Act takes effect immediately if it receives 26 a vote of two-thirds of all the members elected to each house, as 27 provided by Section 39, Article III, Texas Constitution. If this
