4	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
5	SECTION 1. Section 171.002(4), Health and Safety Code, is
6	amended to read as follows:
7	(4) "Sonogram" means the use of ultrasonic waves for
8	diagnostic or therapeutic purposes, specifically to monitor an
9	embryo or fetus [unborn child].
10	SECTION 2. Section 171.012(a), Health and Safety Code, is
11	amended to read as follows:
12	(a) Consent to an abortion is voluntary and informed only
13	if:
14	(1) the physician who is to perform the abortion
15	informs the pregnant woman on whom the abortion is to be performed
16	of:
17	(A) the physician's name;
18	(B) the particular medical risks associated with
19	the particular abortion procedure to be employed, including, when

(i) the risks of infection and hemorrhage;

(ii) the potential danger to a subsequent

[(iii) the possibility of increased risk of 1 breast cancer following an induced abortion and the natural 2 protective effect of a completed pregnancy in avoiding breast 3 4 cancer; 5 (C) the probable gestational age of the embryo or fetus [unborn child] at the time the abortion is to be performed; 6 7 and 8 (D) the medical risks associated with carrying the child to term; 9 10 (2)the physician who is to perform the abortion or the physician's agent informs the pregnant woman that: 11 medical assistance benefits may be available 12 (A) for prenatal care, childbirth, and neonatal care; 13 the father is liable for assistance in the 14 (B) 15 support of the child without regard to whether the father has offered to pay for the abortion; and 16 17 (C) public and private agencies provide pregnancy prevention counseling and medical referrals 18 for 19 obtaining pregnancy prevention medications or devices, including emergency contraception for victims of rape or incest; 20 21 (3) the physician who is to perform the abortion or the physician's agent: 22 23 provides the pregnant woman with the 24 printed materials described by Section 171.014; and 25 (B) informs the pregnant woman that those

1 State Health Services; 2 (ii) are accessible on an Internet website 3 sponsored by the department; 4 (iii) describe the embryo or fetus [unborn 5 child] and list agencies that offer alternatives to abortion; and 6 (iv) include a list of agencies that offer 7 sonogram services at no cost to the pregnant woman; 8 before any sedative or anesthesia is administered to the pregnant woman and at least 24 hours before the abortion or 9 at least two hours before the abortion if the pregnant woman waives 10 this requirement by certifying that she currently lives 100 miles 11 or more from the nearest abortion provider that is a facility 12 licensed under Chapter 245 or a facility that performs more than 50 13 14 abortions in any 12-month period: (A) the physician who is to perform the abortion 15 or an agent of the physician who is also a sonographer certified by 16 17 a national registry of medical sonographers performs a sonogram on the pregnant woman on whom the abortion is to be performed; 18 19 the physician who is to perform the abortion displays the sonogram images in a quality consistent with current 20 medical practice in a manner that the pregnant woman may view them; 21 22 the physician who is to perform the abortion

provides, in a manner understandable to a layperson, a verbal

explanation of the results of the sonogram images, including a

medical description of the dimensions of the embryo or fetus, the

presence of cardiac activity, and the presence of external members

and internal organs; and

- (D) the physician who is to perform the abortion or an agent of the physician who is also a sonographer certified by a national registry of medical sonographers makes audible the heart auscultation for the pregnant woman to hear, if present, in a quality consistent with current medical practice and provides, in a manner understandable to a layperson, a simultaneous verbal explanation of the heart auscultation;
- 8 (5) before receiving a sonogram under Subdivision 9 (4)(A) and before the abortion is performed and before any sedative 10 or anesthesia is administered, the pregnant woman completes and 11 certifies with her signature an election form that states as 12 follows:

13 "ABORTION AND SONOGRAM ELECTION

- 14 (1) THE INFORMATION AND PRINTED MATERIALS
 15 DESCRIBED BY SECTIONS 171.012(a)(1)-(3), TEXAS HEALTH
 16 AND SAFETY CODE, HAVE BEEN PROVIDED AND EXPLAINED TO
 17 ME.
- 18 (2) I UNDERSTAND THE NATURE AND
 19 CONSEQUENCES OF AN ABORTION.
- 20 (3) TEXAS LAW REQUIRES THAT I RECEIVE A
 21 SONOGRAM PRIOR TO RECEIVING AN ABORTION.
- 22 (4) I UNDERSTAND THAT I HAVE THE OPTION TO
 23 VIEW THE SONOGRAM IMAGES.
- 24 (5) I UNDERSTAND THAT I HAVE THE OPTION TO
 25 HEAR THE HEARTBEAT.
- 26 (6) I UNDERSTAND THAT I AM REQUIRED BY LAW
 27 TO HEAR AN EXPLANATION OF THE SONOGRAM IMAGES UNLESS I

1	CERTIFY IN WRITING TO ONE OF THE FOLLOWING:
2	I AM PREGNANT AS A RESULT OF A SEXUAL
3	ASSAULT, INCEST, OR OTHER VIOLATION OF THE TEXAS PENAL
4	CODE THAT HAS BEEN REPORTED TO LAW ENFORCEMENT

- 7 (7) the pregnant woman is provided the name of each 8 person who provides or explains the information required under this 9 subsection.
- SECTION 3. Section 171.014(f), Health and Safety Code, is amended to read as follows:
- In addition to any other organization or entity, the 12 department shall use the American College of Obstetricians and 13 14 Gynecologists as the resource in developing information required to 15 be provided under Sections 171.012(a)(1)(B) and (D), Sections 171.012(a)(2)(A), (B), and (C), and Section 171.016, and in 16 17 maintaining the department's Internet website. Information described by this subsection must be verified and supported by 18 research that is recognized as medically accurate, objective, and 19 complete by the National Institutes of Health and affiliated 20 organizations. 21
- 22 SECTION 4. Section 171.015, Health and Safety Code, is 23 amended to read as follows:
- Sec. 171.015. INFORMATION RELATING TO PUBLIC AND PRIVATE AGENCIES. The informational materials must include:
- 26 (1) geographically indexed materials designed to 27 inform the pregnant woman of public and private agencies and

- 1 services that:
- 2 (A) are available to assist a woman through
- 3 pregnancy, childbirth, and the child's dependency, including:
- 4 (i) a comprehensive list of adoption
- 5 agencies;
- 6 (ii) a description of the services the
- 7 adoption agencies offer;
- 8 (iii) a description of the manner,
- 9 including telephone numbers, in which an adoption agency may be
- 10 contacted; and
- 11 (iv) a comprehensive list of agencies and
- 12 organizations that offer sonogram services at no cost to the
- 13 pregnant woman; and
- 14 (B) are available to provide information and
- 15 services related to family planning [do not provide abortions or
- 16 abortion-related services or make referrals to abortion providers;
- 17 and
- 18 [(C) are not affiliated with organizations that
- 19 provide abortions or abortion-related services or make referrals to
- 20 abortion providers]; and
- 21 (2) a toll-free, 24-hour telephone number that may be
- 22 called to obtain an oral list and description of agencies described
- 23 by Subdivision (1) that are located near the caller and of the

- 25 SECTION 5. Section 171.016, Health and Safety Code, is
- 26 amended to read as follows:
- Sec. 171.016. INFORMATION RELATING TO CHARACTERISTICS OF

- 1 EMBRYO OR FETUS [UNBORN CHILD]. (a) The informational materials
- 2 must include materials designed to inform the woman of the probable
- 3 anatomical and physiological characteristics of the embryo or fetus
- 4 [unborn child] at two-week gestational increments from the time
- 5 when a woman can be known to be pregnant to full term, including any
- 6 relevant information on the possibility of the embryo's or fetus's
- 7 [unborn child's] survival.
- 8 (b) The materials must include color pictures representing
- 9 the development of the embryo or fetus [child] at two-week
- 10 gestational increments. The pictures must contain the dimensions
- 11 of the embryo or fetus [unborn child] and must be realistic.
- 12 (c) The materials provided under this section must be
- 13 objective and nonjudgmental and be designed to convey only accurate
- 14 scientific information about the embryo or fetus [unborn child] at
- 15 the various gestational ages. <u>Information in the materials must be</u>
- 16 <u>verified</u> and supported by research that is recognized as medically
- 17 accurate, objective, and complete by the National Institutes of
- 18 Health and affiliated organizations.
- 19 SECTION 6. (a) By not later than December 1, 2015, the
- 20 Department of State Health Services shall:
- 21 (1) revise the informational materials the department
- 22 is required to publish under Section 171.014, Health and Safety
- 23 Code, as amended by this Act; and
- 24 (2) make the materials available for distribution.
- 25 (b) The changes in law made by this Act apply only to the
- 26 information a physician is required to provide under Section
- 27 171.012, Health and Safety Code, as amended by this Act, on or after
