5	SECTION 1. Subchapter B, Chapter 622, Business & Commerce
6	Code, is amended by adding Section 622.0545 to read as follows:
7	Sec. 622.0545. SAVINGS PROMOTION RAFFLE. This chapter does
8	not apply to a savings promotion raffle authorized under Chapter
9	279, Finance Code.
10	SECTION 2. Subtitle 2, Title 3, Finance Code, is amended by
11	adding Chapter 279 to read as follows:
12	CHAPTER 279. SAVINGS PROMOTION RAFFLE
13	Sec. 279.001. DEFINITIONS. In this chapter:
14	(1) "Credit union" has the meaning assigned by Section
15	121.002.
16	(2) "Deposit," with respect to a financial
17	institution, has the meaning assigned by Section 31.002.
18	(3) "Finance commission" means the Finance Commission
19	of Texas.
20	(4) "Financial institution" has the meaning assigned
21	by Section 31.002.
22	(5) "Savings promotion raffle" means a raffle
23	conducted by a credit union or financial institution in which the
24	sole action required for a chance of winning a designated prize is

the deposit of at least a specified amount of money in a savings 1 account or other savings program offered by the credit union or 2 3 financial institution. 4 Sec. 279.002. SAVINGS PROMOTION RAFFLE BY CREDIT UNION. (a) 5 A credit union may conduct a savings promotion raffle if: 6 (1) each ticket or token representing an entry in the 7 raffle has an equal probability of being drawn; and (2) the raffle is conducted in a manner that: 8 9 (A) does not jeopardize the ability of the credit union to operate in a safe and sound manner; and 10 (B) does not mislead the credit union's members. 11 12 (b) A credit union shall maintain all records the Credit Union Commission determines are necessary to conduct an audit of a 13 14 savings promotion raffle by the Credit Union Department. 15 (c) The Credit Union Commission shall adopt rules and procedures for the administration of this section. 16 17 (d) The provisions of this section applicable to a credit union apply to an organization composed exclusively of credit 18 19 unions. Sec. 279.003. SAVINGS PROMOTION RAFFLE BY CERTAIN FINANCIAL 20 INSTITUTIONS. (a) A financial institution may conduct a savings 21 promotion raffle if: 22 23 (1) each ticket or token representing an entry in the 24 raffle has an equal probability of being drawn; and 25 (2) the raffle is conducted in a manner that: 26 (A) does not jeopardize the ability of the 27 institution to operate in a safe and sound manner; and

1	(B) does not mislead the institution's
2	depositors.
3	(b) A financial institution that conducts a savings
4	promotion raffle under this section shall maintain all records the
5	finance commission determines are necessary to conduct an audit of
6	the raffle by the financial regulatory agency of this state having
7	regulatory jurisdiction over that financial institution.
8	(c) The provisions of this section applicable to a financial
9	institution apply to an organization composed exclusively of
10	financial institutions of the type approved by the finance
11	commission to conduct a savings promotion raffle under Subsection
12	<u>(a).</u>
13	(d) The finance commission shall adopt rules and procedures
14	for the administration of this section.
15	Sec. 279.004. ACCOUNT OR DEPOSIT NOT CONSIDERATION. For
16	purposes of Chapter 47, Penal Code, or other state law, opening or
17	making a deposit in an account is not considered a purchase,
18	payment, or provision of a thing of value for participation in a
19	savings promotion raffle and is not considered to require a
20	substantial expenditure of time, effort, or inconvenience.
21	SECTION 3. This Act takes effect September 1, 2015.
