1-28 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

1-29 SECTION 1. Section 403.302(j), Government Code, is amended
 1-30 to read as follows:

 1-58 education on or after the effective date of this Act.

1-59 SECTION 4. This Act takes effect January 1, 2016.
