- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. DEFINITIONS. In this Act:
- 6 (1) "Commission" means the Texas Commission on
- 7 Environmental Quality.
- 8 (2) "Recycling" has the meaning assigned by Section
- 9 361.421, Health and Safety Code.
- 10 SECTION 2. STUDY OF ECONOMIC IMPACTS OF RECYCLING. (a) The
- 11 commission shall conduct a study on the current and potential
- 12 economic impacts of recycling, including state and local revenue
- 13 that may be considered lost because recyclable materials are not
- 14 recycled. The study must:
- 15 (1) assess current recycling efforts, including by:
- 16 (A) quantifying the amount of materials
- 17 currently being recycled;
- 18 (B) assessing the cost, value, and quality of
- 19 materials currently being recycled; and
- 20 (C) estimating the amount of materials that could
- 21 be recycled but are not currently being recycled;
- 22 (2) identify methods that may be used, by the public
- 23 sector, the private sector, or both, to increase recycling,
- 24 including through the development of:

- 1 (A) new markets for recycled materials; and
- 2 (B) new businesses that may result from
- 3 recycling;
- 4 (3) investigate the current and potential
- 5 availability of funding for the methods identified under
- 6 Subdivision (2);
- 7 (4) assess the current types and number of jobs
- 8 associated with recycling and potential additional opportunities
- 9 for job creation that may result from increased recycling; and
- 10 (5) assess infrastructure needs and development
- 11 opportunities associated with recycling in rural areas.
- 12 (b) To the extent practicable, the commission shall use
- 13 methodologies developed for other recycling studies performed in
- 14 this state in performing the study under this section.
- 15 (c) The commission shall prepare a written report on the
- 16 results of the study and include the report in the 2016 summary
- 17 report titled "Municipal Solid Waste in Texas: A Year in Review."
- SECTION 3. EXPIRATION. This Act expires August 31, 2017.
- 19 SECTION 4. EFFECTIVE DATE. This Act takes effect
- 20 immediately if it receives a vote of two-thirds of all the members
- 21 elected to each house, as provided by Section 39, Article III, Texas
- 22 Constitution. If this Act does not receive the vote necessary for
- 23 immediate effect, this Act takes effect September 1, 2015.
