12	shall conspicuously display a sign that satisfies the requirements

14	patient consulting room.
15	(b) The sign required by this section must be in English and
16	Spanish and display the following text:
17	You can't be forced. No one can make you have an abortion
18	against your will, even if you are a minor. In fact, forcing a
19	minor to have an abortion is considered child abuse. If you
20	are a minor being forced into making a particular decision,
21	you can report it by calling the Texas Abuse Hotline at
22	1-800-252-5400. The call is free and the hotline operates 24
23	hours per day, 365 days per year.
24	You and the father. The father of your child must provide

7 (c) The executive commissioner of the Health and Human
8 Services Commission shall adopt rules as necessary to implement and
9 enforce this section.

10 SECTION 2. Not later than December 1, 2015, the executive 11 commissioner of the Health and Human Services Commission shall 12 adopt the rules necessary to implement Sections 171.0125 and 13 171.0126, Health and Safety Code, as added by this Act.

14 SECTION 3. An ambulatory surgical center or abortion 15 facility is not required to comply with Sections 171.0125 and 16 171.0126, Health and Safety Code, as added by this Act, before 17 January 1, 2016.

SECTION 4. This Act takes effect September 1, 2015.
