A BILL TO BE ENTITLED

AN ACT

2 relating to the content of detailed reports filed by registered 3 lobbyists.

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

5 SECTION 1. Sections 305.0061(a), (b), and (c), Government 6 Code, are amended to read as follows:

7 (a) If a registrant or a person on the registrant's behalf with the registrant's consent or ratification 8 and makes expenditures that exceed \$50 [60 percent of the amount of the 9 legislative per diem in] a day for transportation or lodging for a 10 11 member of the legislative or executive branch or for the immediate 12 family of a member of the legislative or executive branch, the registrant shall also state the following on the report filed under 13 14 Section 305.006:

15 (1) the name of the member of the legislative or16 executive branch in whose behalf the expenditure is made;

17 (2) the place and date of the transportation or18 lodging; and

the purpose of the transportation or lodging. 19 (3) 20 (b) If a registrant or a person on the registrant's behalf 21 and with the registrant's consent or ratification makes expenditures that exceed \$50 [60 percent of the amount of the 22 legislative per diem in] a day for food and beverages for a member 23 of the legislative or executive branch or for the immediate family 24

of a member of the legislative or executive branch or makes expenditures that exceed \$50 [60 percent of the amount of the legislative per diem in] a day for entertainment for a member of the legislative or executive branch or for the immediate family of a member of the legislative or executive branch, the registrant shall also state the following on the report filed under Section 305.006:

7 (1) the name of the member of the legislative or
8 executive branch in whose behalf the expenditure is made;

9

(2) the place and date of the expenditure; and

10 (3) the amount of the expenditure by the appropriate11 category of the amount, as determined by the commission.

(c) If a registrant or a person on the registrant's behalf and with the registrant's consent or ratification gives to a member of the legislative or executive branch, or to the immediate family <u>of a member of the legislative or executive branch</u>, a gift or an award or memento, the value of which exceeds \$50 per gift, award, or memento, the registrant shall also state the following on the report filed under Section 305.006:

19 (1) the name of the member of the legislative or20 executive branch in whose behalf the expenditure is made;

21 (2) a general description of the gift, award, or 22 memento; and

(3) the amount of the expenditure by the appropriatecategory of the amount, as determined by the commission.

25 SECTION 2. Section 305.0061(g), Government Code, is 26 repealed.

27 SECTION 3. The changes in law made by this Act apply only to

1 a gift, award, or memento given to or expenditures for transportation, lodging, food, beverages, or entertainment made 2 for a member of the legislative or executive branch or the immediate 3 family of a member of the legislative or executive branch on or 4 5 after the effective date of this Act. A gift, award, or memento given to or an expenditure for transportation, lodging, food, 6 beverages, or entertainment made for a member of the legislative or 7 8 executive branch or the immediate family of a member of the legislative or executive branch before the effective date of this 9 Act is governed by the law in effect on the date the gift, award, or 10 memento was given, or the date the expenditure for transportation, 11 lodging, food, beverages, or entertainment was made, and the former 12 law is continued in effect for that purpose. 13
