 1-22 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
 1-23 SECTION 1. Section 386.002, Health and Safety Code, is
 1-24 amended to read as follows:
 1-25 Sec. 386.002. EXPIRATION. This chapter expires August 31,

 1-55 Act takes effect September 1, 2015.
