SECTION 4. Article 44.47, Code of Criminal Procedure, is
repealed.

SECTION 5. The change in law made by this Act applies only 3 an order of a juvenile court waiving jurisdiction and 4 to 5 transferring a child to criminal court that is issued on or after the effective date of this Act. An order of a juvenile court 6 7 waiving jurisdiction and transferring a child to criminal court that is issued before the effective date of this Act is governed by 8 the law in effect on the date the order was issued, and the former 9 law is continued in effect for that purpose. 10
