A BILL TO BE ENTITLED

1	AN ACT
2	relating to the establishment and administration by the Texas
3	Higher Education Coordinating Board of a textbook affordability
4	pilot program at a public institution of higher education.
5	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
6	SECTION 1. Subchapter C, Chapter 61, Education Code, is
7	amended by adding Section 61.0667 to read as follows:
8	Sec. 61.0667. TEXTBOOK AFFORDABILITY PILOT PROGRAM.
9	(a) In this section:
10	(1) "College bookstore" means a bookstore that is:
11	(A) operated by an institution of higher
12	education; or
13	(B) in a contractual relationship or otherwise
14	affiliated with an institution of higher education.
15	(2) "Electronic textbook" means a textbook accessed
16	through computer software, interactive videodisc, magnetic media,
17	CD-ROM, computer courseware, online services, an electronic
18	medium, or other means of conveying information to the student or
19	otherwise contributing to the learning process through electronic
20	means, including an open-source textbook.
21	(3) "Eligible institution" means an institution of
22	higher education that has:
23	(A) a total undergraduate student enrollment of
24	more than 18,000; and

1	(B) a college bookstore.
2	(4) "Open-source textbook" means an electronic
3	textbook that is available for downloading from the Internet at no
4	charge to a student and without requiring the purchase of an unlock
5	code, membership, or other access or use charge, except for a charge
6	to order an optional printed copy of all or part of the textbook.
7	(b) The board shall establish and administer a pilot program
8	to encourage the use of affordable textbooks at institutions of
9	higher education. The board shall select one eligible institution
10	to participate in the pilot program.
11	(c) The board by rule shall establish the application
12	process and selection criteria for participation in the pilot
13	program. If no eligible institutions apply, the board may select
14	any eligible institution to participate in the pilot program.
15	(d) The board shall designate one academic department of the
16	selected eligible institution to implement the pilot program. The
17	designated department shall:
18	(1) to the greatest extent possible, use electronic or
19	open-source textbooks, open educational resources, public domain
20	material, or other free or low-cost textbooks or textbook
21	alternatives for each course offered through the department;
22	(2) notify the institution's college bookstore of each
23	textbook or textbook alternative that has been adopted for use in a
24	course offered through the department and that will be distributed
25	through the bookstore; and

(3) maintain records of the cost of textbooks and

- 1 department for the duration of the pilot program.
- 2 (e) On receipt of notice from the designated department
- 3 under Subsection (d)(2), the selected eligible institution's
- 4 college bookstore shall notify the designated department of the
- 5 anticipated cost to a student of each textbook or textbook
- 6 alternative that has been adopted for use in a course offered
- 7 through the department and that will be distributed through the
- 8 bookstore.
- 9 (f) Not later than December 1, 2018, the board shall submit
- 10 to the governor, lieutenant governor, speaker of the house of
- 11 representatives, and presiding officer of each standing
- 12 legislative committee with primary jurisdiction over higher
- 13 education a report on the success of the pilot program under this
- 14 section and any recommendations for legislative or other action.
- 15 The report must include a comparison of the average cost of
- 16 textbooks for courses offered through the department designated
- 17 under Subsection (d) to implement the pilot program and for courses
- 18 offered through departments at other institutions of higher
- 19 education that have implemented a similar textbook affordability
- 20 program.
- 21 (g) On request by the board, the eligible institution
- 22 <u>selected to participate in the pilot program shall assist in</u>
- 23 preparing the report required under Subsection (f).
- 24 (h) The board may solicit and accept gifts, grants, and
- 25 donations from any public or private source to prepare the report
- 26 and develop recommendations as required by Subsection (f).
- 27 (i) The board shall adopt rules as necessary to implement

1 this section.

- 2 <u>(j) This section expires September 1, 2019.</u>
- 3 SECTION 2. The Texas Higher Education Coordinating Board
- 4 shall implement the pilot program required under Section 61.0667,
- 5 Education Code, as added by this Act, beginning with the 2015-2016
- 6 academic year.
- 7 SECTION 3. This Act takes effect immediately if it receives
- 8 a vote of two-thirds of all the members elected to each house, as
- 9 provided by Section 39, Article III, Texas Constitution. If this
- 10 Act does not receive the vote necessary for immediate effect, this
- 11 Act takes effect September 1, 2015.
