1-27BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:1-28SECTION 1. Subchapter H, Chapter 151, Tax Code, is amended

1-30 Sec. 151.3335. WATER-EFFICIENT PRODUCTS. (a) In this 1-31 section, "WaterSense product" means a product that has been 1-32 designated as a WaterSense certified product under the WaterSense 1-33 program operated by the United States Environmental Protection 1-34 Agency, or a similar successor program.

1-35 1-36 (b) The sale of a WaterSense product is exempted from the 1-36 taxes imposed by this chapter if the sale takes place during the 1-37 period described by Section 151.333(c). 1-38 SECTION 2. This Act takes effect July 1, 2015, if it

This Act takes effect July 1, 2015, if it 1-39 receives a vote of two-thirds of all the members elected to each 1-40 house, as provided by Section 39, Article III, Texas Constitution. 1-41 If this Act does not receive the vote necessary for effect on that 1-42 date, this Act takes effect October 1, 2015.
