1-19 A BILL TO BE ENTITLED
 1-20 AN ACT

1-21 relating to the identification requirements of certain health care
 1-22 providers associated with a hospital.

1-23 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

1-24 SECTION 1. Section 241.009, Health and Safety Code, is
 1-25 amended by adding Subsections (c) and (d) to read as follows:

1-26 (c) For purposes of Subsection (b)(3), the identification
 1-27 badge of a health care provider licensed under Title 3, Occupations
 1-28 Code, must clearly state:

1-29 (1) "physician," if the provider holds a license under
 1-30 Subtitle B of that title;

1-31 (2) "chiropractor," "podiatrist," "midwife,"
 1-32 "physician assistant," "acupuncturist," or "surgical assistant,"
 1-33 as applicable, if the provider holds a license under Subtitle C of
 1-34 that title;

1-35 (3) "dentist" or "dental hygienist," as applicable, if
 1-36 the provider holds a license under Subtitle D of that title;

1-37 (4) "licensed vocational nurse," "registered nurse,"
 1-38 "nurse practitioner," "nurse midwife," "nurse anesthetist," or
 1-39 "clinical nurse specialist," as applicable, if the provider holds a
 1-40 license under Subtitle E of that title;

1-41 (5) "optometrist," or "therapeutic optometrist," as
 1-42 applicable, if the provider holds a license under Subtitle F of that
 1-43 title;

1-44 (6) "speech-language pathologist" or "audiologist,"
 1-45 as applicable, if the provider holds a license under Subtitle G of
 1-46 that title;

1-47 (7) "physical therapist," "occupational therapist,"
 1-48 or "massage therapist," as applicable, if the provider holds a
 1-49 license under Subtitle H of that title;

1-50 (8) "medical radiologic technologist," "medical
 1-51 physicist," "perfusionist," "respiratory care practitioner,"
 1-52 "orthotist," or "prosthetist," as applicable, if the provider holds
 1-53 a license or certificate, as appropriate, under Subtitle K of that
 1-54 title; and

1-55 (9) "dietitian," if the provider holds a license under
 1-56 Subtitle M of that title.

1-57 (d) Notwithstanding Subsection (b)(3), a hospital licensed
 1-58 under this chapter is not required to list the type of license held
 1-59 by a provider on a health care provider's photo identification
 1-60 badge until September 1, 2017. This subsection expires September

2-1 1, 2018.

2-2 SECTION 2. This Act takes effect September 1, 2015.
