1-19 A BILL TO BE ENTITLED
 1-20 AN ACT

1-21 relating to route designation for the issuance of a permit for the
 1-22 movement of oversize and overweight vehicles in certain counties.

1-23 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

1-24 SECTION 1. Section 623.219(a), Transportation Code, is
 1-25 amended to read as follows:

1-26 (a) For a permit issued by a port authority located in a
 1-27 county that borders the United Mexican States, the commission
 1-28 shall, with the consent of the port authority, designate the most
 1-29 direct route from:

1-30 (1) the Gateway International Bridge or the Veterans
 1-31 International Bridge at Los Tomates to the entrance of the Port of
 1-32 Brownsville using State Highways 48 and 4 or United States Highways
 1-33 77 and 83 or using United States Highway 77 and United States
 1-34 Highway 83, East Loop Corridor, and State Highway 4; and

1-35 (2) the Free Trade International Bridge to:
 1-36 (A) the entrance of the Port of Brownsville using
 1-37 Farm-to-Market Road 509, United States Highways 77 and 83,
 1-38 Farm-to-Market Road 511, State Highway 550, and East Loop (State
 1-39 Highway 32);

1-40 (B) the eastern entrance of the Port of Harlingen
 1-41 using Farm-to-Market Road 509, United States Highway 77 Business,
 1-42 and Farm-to-Market Road 1846;

1-43 (C) the western entrance of the Port of Harlingen
 1-44 using Farm-to-Market Roads 509 and 106;

1-45 (D) the southern entrance of the Harlingen
 1-46 Industrial Park using Farm-to-Market Road 509; and

1-47 (E) the southern entrance of the Harlingen
 1-48 Aerotropolis at Valley International Airport using Farm-to-Market
 1-49 Road 509.

1-50 SECTION 2. This Act takes effect September 1, 2015.
