1-15 A BILL TO BE ENTITLED
1-16 AN ACT

1-17 relating to the election date of the North Plains Groundwater
1-18 Conservation District.

1-19 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

1-20 SECTION 1. Section 1A(b), Chapter 498, Acts of the 54th
1-21 Legislature, Regular Session, 1955, is amended to read as follows:

1-22 (b) A Directors' election shall be held on a ~~the~~ uniform
1-23 election date ~~in May~~ in each even-numbered year to elect the
1-24 appropriate number of Directors.

1-25 SECTION 2. If the board of directors of the North Plains
1-26 Groundwater Conservation District changes the election date for the
1-27 district as provided by Section 1A(b), Chapter 498, Acts of the 54th
1-28 Legislature, Regular Session, 1955, as amended by this Act, the
1-29 board shall adjust the terms of office to conform to the new
1-30 election date and the requirements of Section 30(c), Article XVI,
1-31 Texas Constitution.

1-32 SECTION 3. (a) The legal notice of the intention to
1-33 introduce this Act, setting forth the general substance of this
1-34 Act, has been published as provided by law, and the notice and a
1-35 copy of this Act have been furnished to all persons, agencies,
1-36 officials, or entities to which they are required to be furnished
1-37 under Section 59, Article XVI, Texas Constitution, and Chapter 313,
1-38 Government Code.

1-39 (b) The governor, one of the required recipients, has
1-40 submitted the notice and Act to the Texas Commission on
1-41 Environmental Quality.

1-42 (c) The Texas Commission on Environmental Quality has filed
1-43 its recommendations relating to this Act with the governor, the
1-44 lieutenant governor, and the speaker of the house of
1-45 representatives within the required time.

1-46 (d) All requirements of the constitution and laws of this
1-47 state and the rules and procedures of the legislature with respect
1-48 to the notice, introduction, and passage of this Act are fulfilled
1-49 and accomplished.

1-50 SECTION 4. This Act takes effect September 1, 2015.
