A BILL TO BE ENTITLED AN ACT

relating to the powers and duties of the Montgomery County Municipal Utility District No. 141; providing authority to issue 1-17 -1**-**18 1-19 bonds and impose taxes.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

SECTION 1. Subtitle F, Title 6, Special District Local Laws is amended by adding Chapter 7912 to read as follows: 1-21 1-22 1-23 Code. CHAPTER 7912. MONTGOMERY COUNTY MUNICIPAL UTILITY DISTRICT NO. 141

SUBCHAPTER A. GENERAL PROVISIONS

7912.001. DEFINITION. In this chapter, "district" means the Montgomery County Municipal Utility District No. 141.

Sec. 7912.002. NATURE AND PURPOSES OF DISTRICT. (a) The district is a municipal utility district created under Section 59, 1-27 1-28 Article XVI, Texas Constitution. 1-29

(b) The district is created to accomplish the purposes of: (1)a municipal utility district as provided by

1-31 general law and Section 59, Article XVI, Texas Constitution; and (2) Section 52, Article III, Texas Constitution, that relate to the construction, acquisition, improvement, operation, 1-32 1 - 331-34 1-35 or maintenance of macadamized, graveled, or paved roads, or improvements, including storm drainage, in aid of those roads. <u>SUBCHAPTER B. POWERS AND DUTIES</u> <u>Sec. 7912.051. GENERAL POWERS AND DUTIES.</u> The distric 1-36 1-37

1-38 The district has 1-39 the powers and duties necessary to accomplish the purposes for which the district is created. 1-40

Sec. 7912.052. MUNICIPAL UTILITY DISTRICT POWERS AND DUTIES. The district has the powers and duties provided by the general law of this state, including Chapters 49 and 54, Water Code, 1-41 1-42 1-43 applicable to municipal utility districts created under Section 59, 1-44 <u>Article XVI, Texas Constitution.</u> Sec. 7912.053. AUTHORITY FOR ROAD PROJECTS. Under Section 1-45

1-46 52, Article III, Texas Constitution, the district may design, acquire, construct, finance, issue bonds for, improve, operate, 1-47 1-48 1-49 maintain, and convey to this state, a county, or a municipality for operation and maintenance macadamized, graveled, or paved roads, or improvements, including storm drainage, in aid of those roads. Sec. 7912.054. ROAD STANDARDS AND REQUIREMENTS. (a) A road project must meet all applicable construction standards, 1-50 1-51

1-52 1-53 1-54 zoning and subdivision requirements, and regulations of each municipality in whose corporate limits or extraterritorial jurisdiction the road project is located. 1-55 1-56

(b) If a road project is not located in the corporate limits or extraterritorial jurisdiction of a municipality, the road project must meet all applicable construction standards, 1-57 1-58 1-59 subdivision requirements, and regulations of each county in which 1-60 1-61 the road project is located.

(c) If the state will maintain and operate one -Transportation Commission must approve the plans 2-1 the road, the 2-2 Texas and 2-3 specifications of the road project.

SUBCHAPTER C. BONDS AND OTHER OBLIGATIONS

Sec. 7912.101. AUTHORITY TO ISSUE BONDS AND OTHER OBLIGATIONS FOR ROAD PROJECTS. (a) The district may issue bonds 2-5 2-6 2-7 other obligations payable wholly or partly from ad valorem or 2-8 taxes, revenue, contract payments, grants, or other district money, or any combination of those sources, to pay for a road project 2-9 2**-**10 2**-**11 authorized by Section 7912.053. (b) The district may not issue bonds payable from ad valorem

2-12 taxes to finance a road project unless the issuance is approved by a 2-13 vote of a two-thirds majority of the district voters voting at an election held for that purpose. 2-14

2**-**15 2**-**16 (c) At the time of issuance, the total principal amount of or other obligations issued or incurred to finance road bonds 2-17 projects and payable from ad valorem taxes may not exceed 2-18 one-fourth of the assessed value of the real property in the district. 2-19

Sec. 7912.102. TAXES FOR BONDS. At the time the district issues bonds payable wholly or partly from ad valorem taxes, the district shall provide for the annual imposition of a continuing 2-20 2-21 2-22 direct ad valorem tax, without limit as to rate or amount, while all 2-23 or part of the bonds are outstanding as required and in the manner 2-24 provided by Sections 54.601 and 54.602, Water Code. SECTION 2. The Montgomery County Municipal Utility District

2**-**25 2**-**26 2-27 No. 141 retains all rights, powers, privileges, authority, duties, 2-28 and functions that it had before the effective date of this Act.

2-29 SECTION 3. (a) The legislature validates and confirms all governmental acts and proceedings of the Montgomery County Municipal Utility District No. 141 that were taken before the 2-30 2-31 2-32 effective date of this Act.

2-33 (b) This section does not apply to any matter that on the effective date of this Act: 2-34

2-35 (1) is involved in litigation if the litigation 2**-**36 ultimately results in the matter being held invalid by a final court 2-37 judgment; or 2-38

(2) has been held invalid by a final court judgment.

SECTION 4. (a) The legal notice of the intention to introduce this Act, setting forth the general substance of this Act, has been published as provided by law, and the notice and a copy of this Act have been furnished to all persons, agencies, 2-39 2-40 2-41 2-42 officials, or entities to which they are required to be furnished 2-43 2-44 under Section 59, Article XVI, Texas Constitution, and Chapter 313, 2-45 Government Code.

2-46 The governor, one of the required recipients, has the notice and Act to the Texas Commission on (b) 2-47 submitted 2-48 Environmental Quality.

2-49 (c) The Texas Commission on Environmental Quality has filed its recommendations relating to this Act with the governor, the lieutenant governor, and the speaker of the house of 2-50 2-51 2-52 representatives within the required time.

2-53 (d) All requirements of the constitution and laws of this state and the rules and procedures of the legislature with respect 2-54 2-55 to the notice, introduction, and passage of this Act are fulfilled 2-56 and accomplished.

This Act takes effect immediately if it receives 2-57 SECTION 5. 2-58 a vote of two-thirds of all the members elected to each house, as provided by Section 39, Article III, Texas Constitution. If this Act does not receive the vote necessary for immediate effect, this 2-59 2-60 2-61 Act takes effect September 1, 2015.
