The chair called the meeting to order at 9:04 AM, the following business was transacted:

The chair laid out SB 1867 and recognized the author, Senator Zaffirini, to explain the bill.

Senator Larry Taylor moved that SB 1867 be left pending; without objection, it was so ordered.
