HB 3599 Turner, Chris Relating to the sale of collateral in connection with certain extensions of consumer credit that a credit access business obtains for a consumer or assists a consumer in obtaining; providing a civil penalty.

HB 3638 Turner, Chris Relating to reports for credit access businesses required by the consumer credit commissioner; amending provisions subject to a criminal penalty.
