1-21 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

1-22 ARTICLE 1. ENTITIES GIVEN 2021 SUNSET DATE

1-23 SECTION 1.01. TEXAS HISTORICAL COMMISSION. Section
 1-24 442.002(k), Government Code, is amended to read as follows:

1-25 (k) The Texas Historical Commission is subject to Chapter
 1-26 325 (Texas Sunset Act). Unless continued in existence as provided
 1-27 by that chapter, the commission is abolished and this chapter
 1-28 expires September 1, 2021 [~~2019~~].

1-29 SECTION 1.02. TEXAS STATE BOARD OF PLUMBING EXAMINERS.
 1-30 Section 1301.003, Occupations Code, is amended to read as follows:

1-31 Sec. 1301.003. APPLICATION OF SUNSET ACT. The Texas State
 1-32 Board of Plumbing Examiners is subject to Chapter 325, Government
 1-33 Code (Texas Sunset Act). Unless continued in existence as provided
 1-34 by that chapter, the board is abolished and this chapter expires
 1-35 September 1, 2021 [~~2019~~].

1-36 ARTICLE 2. ENTITIES GIVEN 2023 SUNSET DATE

1-37 SECTION 2.01. TEXAS MILITARY DEPARTMENT. Section 437.051,
 1-38 Government Code, is amended to read as follows:

1-39 Sec. 437.051. SUNSET PROVISION. The department is subject
 1-40 to Chapter 325 (Texas Sunset Act). Unless continued in existence as
 1-41 provided by that chapter, the department is abolished and this
 1-42 subchapter expires September 1, 2023 [~~2019~~].

1-43 SECTION 2.02. TEXAS STATE LIBRARY AND ARCHIVES COMMISSION.
 1-44 Section 441.001(q), Government Code, is amended to read as follows:

1-45 (q) The Texas State Library and Archives Commission is
 1-46 subject to Chapter 325 (Texas Sunset Act). Unless continued in
 1-47 existence as provided by that chapter, the commission is abolished
 1-48 September 1, 2023 [~~2019~~].

1-49 SECTION 2.03. TEXAS DEPARTMENT OF MOTOR VEHICLES. Section
 1-50 1001.005, Transportation Code, is amended to read as follows:

1-51 Sec. 1001.005. SUNSET PROVISION. The department is subject
 1-52 to Chapter 325, Government Code (Texas Sunset Act). Unless
 1-53 continued in existence as provided by that chapter, the department
 1-54 is abolished September 1, 2023 [~~2019~~].

1-55 ARTICLE 3. EFFECTIVE DATE

1-56 SECTION 3.01. EFFECTIVE DATE. This Act takes effect
 1-57 immediately if it receives a vote of two-thirds of all the members
 1-58 elected to each house, as provided by Section 39, Article III, Texas
 1-59 Constitution. If this Act does not receive the vote necessary for
 1-60 immediate effect, this Act takes effect on the 91st day after the
 1-61 last day of the legislative session.
