- 1 Amend C.S.S.B. No. 1 (house committee printing) as follows:
- 2 (1) In Article I of the bill, in the appropriations to the
- 3 Trusteed Programs Within the Office of the Governor, Method of
- 4 Financing listing for General Revenue Fund Dedicated, for
- 5 Texas Enterprise Fund Account No. 5107 (page I-49), strike ",
- 6 estimated".
- 7 (2) Reduce the Article I appropriations to the Trusteed
- 8 Programs Within the Office of the Governor for Strategy C.1.4,
- 9 Texas Enterprise Fund (page I-51), by \$3,000,000 for the state
- 10 fiscal biennium ending August 31, 2019.
- 11 (3) Add the following appropriately numbered rider
- 12 following the Article I bill pattern appropriations to Trusteed
- 13 Programs Within the Office of the Governor (page I-55),:
- 14 . Contingency for HB 4195 or SB 1410. If H.B. No. 4195
- 15 or S.B. No. 1410 or other similar legislation of the 85th
- 16 Legislature, Regular Session, 2017, relating to establishing a
- 17 pilot program to assist small businesses in obtaining capital
- 18 becomes law, the additional amount of \$3,000,000 is appropriated
- 19 from the general revenue fund to the Trusteed Programs Within
- 20 the Office of the Governor for Strategy C.1.1., Economic
- 21 Development, for the state fiscal year ending August 31, 2018,
- 22 to provide funding for the purpose of creating a pilot program
- 23 to assist small businesses in obtaining capital, and any
- 24 unexpended balance of that amount remaining as of August 31,
- 25 2018, is appropriated for the same purpose for the state fiscal
- 26 year ending August 31, 2019. If H.B. No. 4195 or S.B. No. 1410
- 27 or other similar legislation of the 85th Legislature, Regular
- 28 Session, 2017, relating to establishing a pilot program to
