The district is a fresh water supply district created under and essential to accomplish the 1-33 purposes of Section 52, Article III, and Section 59, Article XVI, 1-34 1-35 Texas Constitution. Sec. 6917.003. Sec. 6917.003. FINDINGS OF BENEFIT AND PUBLIC PURPOSE. (a) The district is created to serve a public use and benefit. 1-36 1-37 1-38 (b) All land and other property included in the district benefit from the improvements and services to be provided by 1-39 will the district under powers conferred by Sections 52 and 52-a, Article III, and Section 59, Article XVI, Texas Constitution, and other powers granted under this chapter. 1-40 1-41 1-42 The creation of the district is in the public interest 1-43 (c) 1-44 and is essential to further the public purposes of: 1-45 (1) developing and diversifying the economy of the 1-46 state; 1-47 (2)eliminating unemployment and underemployment; and 1-48 (3) developing or expanding transportation and 1-49 commerce. 1-50 (d) The district will: (1) promote the health, safety, and general welfare of residents, employers, potential employees, employees, visitors, and consumers in the district, and of the public; 1-51 1-52 1-53 1-54 (2) provide needed funding for the district to preserve, maintain, and enhance the economic health and vitality of 1-55 1-56 the district territory as a community and business center; and (3) promote the health, safety, welfare, and enjoyment 1-57 of the public by providing pedestrian ways and by landscaping and 1-58 1-59 developing certain areas in the district, which are necessary for the restoration, preservation, and enhancement of scenic beauty. 1-60

C.S.H.B. No. 1208 (e) Pedestrian ways along or across a street, whether at grade or above or below the surface, and street lighting, street landscaping, vehicle parking, and street art objects are parts of and necessary components of a street and are considered to be an improvement project that includes a street or road improvement. Sec. 6917.004. APPLICABILITY OF OTHER LAW. Except as otherwise provided by this chapter, the following laws apply to the district: (1) Chapters 49, 51, and 53, Water Code;
(2) Chapters 372 and 375, Local Government Code; and
(3) Chapter 257, Transportation Code, and other general laws applicable to road districts created under Section 52, Article III, Texas Constitution, to the extent those provisions can apply to the district. SUBCHAPTER B. POWERS AND DUTIES Sec. 6917.051. AUTHORITY FOR ROAD PROJECTS. Under Section Article III, Texas Constitution, the district may design, 52, <u>acquire, construct, finance, issue bonds for, improve, operate,</u> maintain, and convey to this state, a county, or a municipality for operation and maintenance macadamized, graveled, concreted, or paved roads, or improvements, including storm drainage, in aid of those roads. Sec. 6917.052. ROAD STANDARDS AND REQUIREMENTS. (a) A road project must meet all applicable construction standards, zoning and subdivision requirements, and regulations of each municipality in whose corporate limits or extraterritorial jurisdiction the road project is located. (b) If a road project is not located in the corporate limits or extraterritorial jurisdiction of a municipality, the road project must meet all applicable construction standards, project must meet all applicable construction standards, subdivision requirements, and regulations of each county in which the road project is located. (c) If the state will maintain and operate the road, the Transportation Commission must approve the plans and Texas specifications of the road project. Sec. 6917.053. JOINT ROAD PROJECTS. A district may (a) contract with a state agency, political subdivision, or corporation created under Chapter 431, Transportation Code, for a joint road project. (b) The contract may: (1) provide for joint payment of project costs; and (2) require the state agency, political subdivision, corporation to design, construct, or improve a project, including landscaping, as provided by the contract. Sec. 6917.054. EXEMPTION FROM CERTAIN SUPERVISION AND APPROVAL REQUIREMENTS. (a) The district may reimburse expenditures as provided by Sections 257.003(a) and (b), Transportation Code, without the approval required by Section <u>257.003(c), Transportation Code.</u> (b) The district may reimburse expenditures for a project constructed or acquired under Section 6917.051 or 6917.053 without the approval required by Section 49.107(f), Water Code. (c) Sections 49.181 and 49.182, Water Code, and Section 375.208, Local Government Code, do not apply to: (1)a project authorized by Section 6917.051 or <u>6917.053;</u> (2) bonds issued for a project described by Subdivision (1); or (3) bonds issued under Chapter 372, Local Government Code, as authorized by Section 6917.151(b). Sec. 6917.055. ROAD CONTRACTS. The district may enter into a contract for a road project in the same manner as a road district under Chapter 257, Transportation Code, except that competitive bidding for a road project contract is governed by Subchapter I, Chapter 49, Water Code. Sec. 6917.056. DIVISION OF DISTRICT. (a) The district may

(f) At the time of issuance, the total principal amount of bonds or other obligations issued or incurred to finance road projects and payable from ad valorem taxes may not exceed 4-19 4-20 4-21 one-fourth of the assessed value of the real property in the 4-22 4-23 district.

SECTION 2. (a) The following are validated and confirmed in 4-24 4**-**25 4**-**26 all respects:

the creation of the Kaufman County Fresh Water (1) 4-27 Supply District No. 1-D; and

4-28 (2) any act or proceeding of the district, including an election, not excepted by this section and taken not more than 4-29 4-30 three years before the effective date of this Act, effective as of 4-31 the date on which the act or proceeding occurred. 4-32 (b)

This section does not apply to:

(1) an act, proceeding, director, other official, bond, or other obligation the validity of which or of whom is the 4-33 4-34 4-35 subject of litigation that is pending on the effective date of this 4-36 Act; or

4-37 (2) an act or proceeding that, under a statute of this 4-38 state or the United States, was a misdemeanor or felony at the time 4-39 the act or proceeding occurred.

SECTION 3. (a) The legal notice of the intention to introduce this Act, setting forth the general substance of this 4-40 4-41 Act, has been published as provided by law, and the notice and a copy of this Act have been furnished to all persons, agencies, 4-42 4-43 officials, or entities to which they are required to be furnished under Section 59, Article XVI, Texas Constitution, and Chapter 313, 4 - 444-45 4-46 Government Code.

4-47 (b) The governor, one of the required recipients, has 4-48 the notice and Act to the Texas Commission submitted on 4-49 Environmental Quality.

4-50 (c) The Texas Commission on Environmental Quality has filed 4-51 its recommendations relating to this Act with the governor, the lieutenant governor, and the speaker of the house 4-52 of 4-53 representatives within the required time.

(d) All requirements of the constitution and laws of this 4-54 4-55 state and the rules and procedures of the legislature with respect 4-56 to the notice, introduction, and passage of this Act are fulfilled 4-57 and accomplished.

4-58 SECTION 4. This Act takes effect immediately if it receives a vote of two-thirds of all the members elected to each house, as provided by Section 39, Article III, Texas Constitution.
