1-19 relating to the licensing and regulation of a journeyman lineman. 1-20 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS: 1-21

SECTION 1. Section 1305.002(12), Occupations Code, is amended to read as follows:

1-22 1-23 (12) "Journeyman lineman" means an individual who electrical work involving the installation, 1-24 engages in maintenance<u>,</u> 1-25 and operation of equipment associated with the 1-26 and distribution of electricity from the transmission electricity's original source to a substation <u>and from a substation</u> to the point where the electricity enters a building or structure on 1-27 1-28 1-29 a customer's premises for further distribution.

1-30 SECTION 2. Section 1305.101(a), Occupations Code, is 1-31 amended to read as follows:
