H.B. No. 1865

A BILL TO BE ENTITLED

1 AN ACT
2 relating to the scheduling of the first and last days of school for
3 students by school districts.

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

5 SECTION 1. Section 12A.003(b), Education Code, is amended
6 to read as follows:

7 (b) A local innovation plan must:

8 (1) provide for a comprehensive educational program
9 for the district, which program may include:

10 (A) innovative curriculum, instructional
11 methods, and provisions regarding community participation, campus
12 governance, and parental involvement;

13 (B) except as provided by Section 12A.004(a),
14 modifications to the school day or year;

15 (C) provisions regarding the district budget and
16 sustainable program funding;

17 (D) accountability and assessment measures that
18 exceed the requirements of state and federal law; and

19 (E) any other innovations prescribed by the board
20 of trustees; and

21 (2) identify requirements imposed by this code that
22 inhibit the goals of the plan and from which the district should be
23 exempted on adoption of the plan, subject to Section 12A.004.

24 SECTION 2. Section 12A.004(a), Education Code, is amended

1 to read as follows:

2 (a) A local innovation plan may not provide for the
3 exemption of a district designated as a district of innovation from
4 the following provisions of this title:

5 (1) a state or federal requirement applicable to an
6 open-enrollment charter school operating under Subchapter D,
7 Chapter 12;

8 (2) Subchapters A, C, D, and E, Chapter 11, except that
9 a district may be exempt from Sections 11.1511(b)(5) and (14) and
10 Section 11.162;

11 (3) state curriculum and graduation requirements
12 adopted under Chapter 28; ~~and~~

13 (4) academic and financial accountability and
14 sanctions under Chapter 39; and

15 (5) the first or last day of instruction requirements
16 under Sections 25.0811 and 25.0812.

17 SECTION 3. Section 25.0811(a), Education Code, is amended
18 to read as follows:

19 (a) Except as provided by this section, a school district
20 may not begin instruction for students for a school year before the
21 Tuesday after Labor Day [~~the fourth Monday in August~~]. A school
22 district may:

23 (1) begin instruction for students for a school year
24 before the Tuesday after Labor Day [~~the fourth Monday in August~~] if
25 the district operates a year-round system under Section 25.084; or

26 (2) begin instruction for students for a school year
27 on or after the first Monday in August at a campus or at not more

1 than 20 percent of the campuses in the district if:

2 (A) the district has a student enrollment of
3 190,000 or more;

4 (B) the district at the beginning of the school
5 year provides, financed with local funds, days of instruction for
6 students at the campus or at each of the multiple campuses, in
7 addition to the minimum [~~number of days of~~] instruction time
8 required under Section 25.081;

9 (C) the campus or each of the multiple campuses
10 is [~~are~~] undergoing comprehensive reform, as determined by the
11 board of trustees of the district; and

12 (D) a majority of the students at the campus or at
13 each of the multiple campuses are educationally disadvantaged.

14 SECTION 4. Section 25.0812, Education Code, is amended by
15 amending Subsection (a) and adding Subsection (a-1) to read as
16 follows:

17 (a) Except as provided by Subsection (a-1) or (b), a school
18 district may not schedule the last day of school for students for a
19 school year before May 15 or after the Friday preceding Memorial
20 Day.

21 (a-1) A school district may schedule the last day of school
22 for students for a school year after the Friday preceding Memorial
23 Day if the district operates a year-round system under Section
24 25.084.

25 SECTION 5. Section 25.084(a), Education Code, is amended to
26 read as follows:

27 (a) A school district may operate its schools year-round on

1 either a single-track or a multitrack calendar. If a school
2 district adopts a year-round system, the district may modify:

3 (1) the number of contract days of employees and the
4 number of days of operation, including any time required for staff
5 development, planning and preparation, and continuing education,
6 otherwise required by law;

7 (2) testing dates, data reporting, and related
8 matters;

9 (3) the date of the first day of instruction of the
10 school year under Section [25.0811](#) and the date of the last day of
11 school for a school year under Section [25.0812](#) for a school that was
12 operating year-round for the 2016-2017 [~~2000-2001~~] school year; and

13 (4) a student's eligibility to participate in
14 extracurricular activities when the student's calendar track is not
15 in session.

16 SECTION 6. This Act applies beginning with the 2018-2019
17 school year.

18 SECTION 7. This Act takes effect immediately if it receives
19 a vote of two-thirds of all the members elected to each house, as
20 provided by Section [39](#), Article III, Texas Constitution. If this
21 Act does not receive the vote necessary for immediate effect, this
22 Act takes effect September 1, 2017.
