## A BILL TO BE ENTITLED AN ACT

relating to the participation in the Texas Municipal Retirement System of certain employees of certain municipalities subject to 1-19 1-20 the Texas Local Fire Fighters Retirement Act. 1-21 1-22

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS: SECTION 1. The Texas Local Fire Fighters Retirement Act 1**-**23 (Article 6243e, Vernon's Texas Civil Statutes) is amended by adding 1-24 1-25 Section 31A to read as follows:

Sec. 31A. AUTHORITY OF CERTAIN RETIREMENT SYSTEMS TO EXCLUDE CERTAIN PERSONS FROM COVERAGE. This Act takes effect September 1, 2017.
