## A BILL TO BE ENTITLED AN ACT

1-20 relating to notice of health benefit plan provider network status 1-21 certain freestanding emergency provided by medical care 1-22 1-23 facilities.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

SECTION 1. Section 241.252, Health and Safety Code, 1-24 is amended by amending Subsection (b) and adding Subsection (e) to 1-25 1-26 read as follows:

(b) 1-27 A facility described by Section 241.251 shall post 1-28 notice that: 1-29

(1)states:
